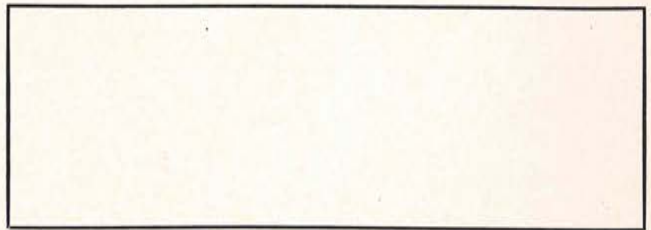

Our expansion of recent years has led to an increasing number of inquiries from both schools and newly formed locals. The Council recently approved the development of colonies at the University of Cincinnati, West Virginia University and Iowa State University. There is a very strong possibility that a colony will be organized in March or April at Iowa State. Chi Phi left Iowa State in 1932 following the loss of the chapter house by fire. Economic conditions, being what they were at that time, were not conducive to replacing the structure and continuing the chapter.

OPENING

BROTHER CHARLES WILSON, Assistant National Director, has resigned effective June 1, 1968. The Council accepted the resignation with a great deal of regret, for "Chuck" has made a vital contribution to the fraternity since his association with the professional staff on January 1, 1967.

Mu Delta Chartered at Auburn

OCTOBER twenty-first nineteen-sixty-seven was a day of note at Auburn University. (Auburn beat Georgia Tech as the University of Alabama bowed to Tennessee.) Most notable for Chi Phi, however, was the occasion of the installation of Mu Delta Chapter, Chi Phi's thirty-ninth chapter, at Auburn.

Chi Phi at Auburn had its beginnings in September of nineteen sixty-four, when James C. Parker, T '62, came from the University of Alabama as the Colonizer. He, under the leadership of Carl J. Gladfelter, Col. (U.S.A. Ret.) B. Conn Anderson, N' 11; D. Wallace Ward, B '56; Frank M. Blodgett, Th D '58; and Andrew J. Gentry, T '63, launched the Auburn Colony of Chi Phi. During its first year, the Colony had no official home, therefore, rush was held in a local motel. Meetings were held in the Auburn Union Building and later at a boarding house. During this time, the membership in the Colony grew from one to thirteen. In the fall of nineteen sixty-five, the Colony moved into a small frame house. This enabled the membership to strengthen its brotherhood, to establish a more effective rush program, and to participate more fully in the activities on the Auburn campus. Fall and Winter quarters of sixty-six brought new activity to the Colony, including the adoption of a seven-year-old Peruvian boy through the Foster Parents' Plan. By Spring quarter, thirty men had been initiated at Tau, Omega, and Gamma Chapters and on April twenty-fifth, nineteen sixty-seven the Colony was approved for membership in the Auburn I.F.C.

Grand Alpha, Joseph R. Dockery, Xi '28, presided at the formal chartering which took place at the Auburn Woman's Club which was the home of the late General Lane of the Confederate Army who served with Stonewall Jackson. The house was built in 1854. Also present were Grand Eta, E. Bates Block, B '40, H '42; Grand Zeta, Wyford D. Jones, A-X '34; and National Director, Carl J. Gladfelter, A-T '33. Immediately following was a social cocktail hour for brothers and their dates or wives in honor of the national officers.

Later that evening the installation banquet was held. Toastmaster for the evening was Brother Sidney R. Hill, Jr., T '65. A history of Chi Phi at Auburn was given by Brother James C. Parker followed by the formal welcome to the Auburn campus by H. Floyd Vallery, Assistant to the President, Auburn University. Brother Dockery then formally presented the Charter and acceptance was made by the Alpha, Robert C. McDonald, MD '68. The

banquet was attended by members of various fraternities, sororities, and other campus groups along with representatives of Gamma, Tau, and Iota Delta chapters and the Colony at Tulane. The evening was wrapped up by a piquant party at which the Cordovans, a North Carolinian group, entertained.

An uncanny but joyful happenstance was the birth of a girl to Brother and Mrs. William H. Ziegler, Jr., MD '69, on the same day. Wendy, Mu Delta's youngest lovelier mate, is now a living symbol of the Chapter's bright future. The chapter has the chance and the potential to aim toward being the top chapter on the Auburn campus. The aim is to grow physically; Bernard Resoto became the first, with many to follow, initiate at Mu Delta. The goal is a brotherhood of sixty. The aim is to grow scholastically; the Colony was as high as third. The goal is to be number one. The aim is to grow socially; two Annual Chakett Balls and early community projects are a start. The goal is to successfully integrate chapter, campus, and community life into a meaningful collegiate experience. The total aim is toward the top, the final goal is true brotherhood.

With its goals set, Mu Delta chapter is ready to step into the future.

Student's View OF HONG KONG AND CHINA

The Hong Kong Situation—October, 1967

SINCE the Communists took over the mainland, Hong Kong has existed in an air of uncertainty; no one knows what the future holds in store. The current situation has re-emphasized this doubt and tension, and shaken the Colony from any complacency which may have set in.

The disturbances began in May during a relatively simple labor dispute between a left-wing labor union and the management of a plastic flower factory. The workers went on strike and the management locked them out of the factory. Orderly demonstrations (with a great deal of shouted Mao-quotations) followed outside the factory gates. The evening the riots began, the strikers were quietly "closing shop" for the day when agitators in the crowd which had gathered to watch, urged the laborers to attack the special police detachment which was present to prevent violence.

The violence soon spread through that area of town, which is composed of factories and resettlement estates. The riots which followed were not connected with the labor dispute or politics. The mobs were made up of young delinquents and known criminals who had an opportunity to attack the police with stones without having to face the consequences. However, communist agitators and criminals did direct the actions of these young people, who became "dupes" for the agitators.

The communists then tried to reap political hay from the riots, calling them an uprising of the patriotic Chinese people against the British imperialists. Police efforts to quell the riots were labeled "Fascist atrocities."

The communists soon came forward with their famous

"five demands," similar to the tactics used by the communists in Macao. The Portuguese now rule Macao in name only; they capitulate to every communist demand and all decisions are actually made by the communists. The Portuguese have lost all respect of the people here. The five demands in Hong Kong almost precipitated a crisis. If they had been pushed by the local communists and given support by Peking, it would have meant the final face-off between Britain and China. In that event, it would have become a matter of face which could not have been avoided. The British would never accept an arrangement such as Macao. They would have pulled out of Hong Kong after insulting the Chinese in some devastating manner. The Chinese, on the other hand, could not have backed down; how could they explain to the local Chinese, to their own country, or to the world why they made five demands and then did not pursue them? It was a tense time as Hong Kong waited to see if the five demands were going to become a real issue or not. As it turned out, the communists changed their tactics.

The communists do not have significant support in Hong Kong. It appears that less than 5% of the population is communist. The overwhelming majority of the people hate communism because they or their relatives or their friends have suffered under the mainland rule, or are still suffering under it. The people tend to support the status quo. The support from the public for the government and the police during the disturbances has been astonishing. Over 400 community organizations,

a well-represented cross section of Hong Kong's population, stated their support for the Government; close to HK\$4,000,000 was donated to a specially formed Police Children's Higher Education Fund and HK\$700,000 was donated to a fund for dependents of victims of communist terrorism and murder.

The general attitude of the population towards the communists is disgust and hatred. The communists' actions have only helped the British image and hurt the Chinese people. The communists are somewhat strong in the transport and food industries. The communist-led bus, ferry and food strikes have caused a sharp rise in the cost of living, which causes disaster in the Chinese family economy but leaves the British unaffected. Thus, the communists are alienating the very people they need support from to gain strength in Hong Kong. Their recent murders and bombings have cost them further sympathy from previously neutral Chinese.

The disturbances and demands, as well as the following events, seem to be under the direction of the local party rather than Peking. Peking probably did not wish to create an uneasy situation in Hong Kong yet; while they dislike the British and dislike having a successful showcase of capitalism on their doorstep, the Chinese desperately need the foreign exchange which comes through Hong Kong, amounting to over 50% of all their hard currency. Peking seems to have been dragged into the situation by the local communists who were trying to duplicate the success of the local party in Macao. Peking has only given verbal support to the actions and

demands of the Hong Kong party and it is believed that Peking gave several stern warnings to the local party not to create a crisis. Yet Peking is in no position to disown their comrades in Hong Kong.

The situation in Hong Kong is one of uneasy calm. While very little business has left the Colony, little new investment is coming in, as opposed to the 20% annual rate of expansion over the last five years. Most people are adopting a wait-and-see attitude. Most wealthy Chinese and all Europeans have no real worries, but almost all the Chinese families cannot leave Hong Kong; any refugees from the mainland cannot receive a passport which makes travel or emigration extremely difficult. And, of course, money is always a problem.

The Future of China

IT IS EXTREMELY DIFFICULT to make an accurate statement about the current situation on the Mainland; Eastern European Communists do not know what is happening, Asians do not know, even the Chinese Communists do not know exactly what is going on. Obviously, the present events are the most important to occur since 1949. I can hazard a few general observations.

It does seem clear that Maoism is on its last legs. Mao had to relinquish some of his individual power as early as 1959. Meanwhile, Liu Shao-Chi has gained increasing popular support by working with local party organizations outside the urban centers of Shanghai and Peking. Mao recognized this as a threat to his waning power and decided in early 1966 to move against Liu. Knowing Liu's power among the party workers, he was forced to move outside the normal party apparatus and resort to the use of the Red Guard youth organizations.

The Mao-Liu dispute seems to include both personal power and policy considerations. Mao is a revolutionary and ideologist who calls for continual struggle within and outside the borders of China; Liu is more pragmatic and wishes to direct China's energies toward internal development, giving basis for Maoist claims that he follows the revisionist road.

It is an indication of Liu's own power and Mao's weakness that Liu has not yet been ousted. The struggle for power has spread throughout China. It would be optimistic to say that the country is breaking up. But events seem to be on the verge of armed civil war. However, it is important to note that not all the anti-Maoists are pro-Liu; the two groups can often be separate and distinct.

The immediate future of China is quite gloomy. The nation is in chaos, and has reached an economic impasse. Any development over the past twenty years has been pretty well nullified by the current disruption. The shortrange prospects seem to be continued struggle. The distant future looks much brighter though. If the Maoists lose their stranglehold on power and more pragmatic forces have a voice in policy formulation, China can become the world power they aspire to be.

It is interesting to realize that the Chinese, both the party leaders and the average citizens, are deathly afraid that the United States will unleash a nuclear attack on the Mainland at any moment. They have a tremendous inferiority complex in respect to technological development, and truly feel they are the victims of "nuclear blackmail." It will be difficult for them to join the world community until they rid themselves of these fears and complexes.

The Hong Kong Student

THE LIFE OF THE STUDENT in Hong Kong is quite different from the life of the average student in the United States. The Hong Kong student, to a great extent, is the victim of the British educational system and the Hong Kong

situation.

The British school system practiced in Hong Kong places far too much emphasis upon examinations. The student attends a six-year primary school. He must then

pass a rigorous examination to qualify for entrance into a six-year middle school. In the sixth year of middle school, all students must take a "school leaving certificate examination" administered by the individual school. If a student wishes to enter a post-secondary school, he must also take the matriculation examination administered by the Education Department. In addition, the student must take an entrance examination for each post-secondary school he applies to for admission.

In the second year of college, all students must successfully complete an "Intermediate Examination" to be allowed to continue their studies. In the final year, the students must pass the Degree Examination, nine papers covering four years of work. All of these examinations are in addition to the normal course examinations given at the end of each semester.

As a result of this stress upon testing, the students must spend the major portion of their time preparing for examinations and cannot pursue studies with the freedom American students enjoy. Since imagination is not rewarded in the examinations, much time is spent in memorization. In addition, students must choose a major and minor in their first year of college; since they normally only take courses in those two departments, their education is much narrower than most American students.

The Hong Kong student often turns out to be a person with narrow interests and little imagination. They can perform well in science and mathematics where memorization and other such talents are valuable, but sometimes fare poorly in the social sciences where abstract theory plays such an important role.

The Hong Kong employment situation also limits the students' freedom. If the student does poorly in the series of qualifying examinations, his chances for satisfactory employment are severely limited. A person who does not qualify for middle school can only obtain work in the lowest forms of manual labor. A person who fails the school-leaving certificate exam will probably only find labor positions open to him. A person who fails the degree examination (percentage of failures varies between departments, ranging from 5% to 60%) cannot earn more than half of what a degree-holder will earn.

Education is neither free nor universal in Hong Kong. There is also a great shortage of vacancies: less than one-tenth of the middle school graduates can attend a regular university. Another 30% attend technical schools or teacher-training colleges; the remainder must seek employment.

With the rigorous examinations and the importance of the degree, the Hong Kong student is usually more serious-minded than his American counterpart. He has diligent study habits, emphasizing memorization, and has little time for extra curricular activities. Social life is practically non-existent and athletics are of little importance.

It would be incorrect to say that the Chinese students spend all their time studying. They do relax by going to movies, listening to music or playing basketball or ping-pong. But their social life is barren in comparison to American campus life. They dress more formally than I was accustomed to at Berkeley. They rarely date; both boys and girls are very reserved, and rarely date in single couples or double. Most dating consists of groups of 10 or 15 going out on a Saturday afternoon, during which the boys (and the girls) quietly investigate the possibility of more personal relationships with a particular person. After a series of group dates, the big plunge of an individual date may be taken. This is truly a serious step, and the whole campus keeps track of the

progress. By the third date, one can assume that the couple is on the verge of engagement.

Saturday evenings are usually spent at home with the family watching television (Gunsmoke in Chinese is quite an experience), or playing mahjong. Sunday may be a family lunch and then back to school.

The Chinese students are really quite bright. Under a less restrictive school system they could match wits equally with American students. But at present they are less imaginative and less enthusiastic. College life is not as enjoyable as American students are accustomed to, and competition is fierce.

Relations with Western people are often strained. While the students and their families are always polite, they are not friendly during the first several months of acquaintance. This is a result of the unequal relationship that has marked Sino-Western relations for the past 150 years. The Chinese are extremely proud of their civilization and its accomplishments; some even feel that China is still the "Middle Kingdom." They sometimes view with disdain the Western peoples' pride in their own societies since the Chinese see such societies as crassly materialistic. The Westerners' arrogance does not help the situation.

However, after eight months I was able to win the students' confidence by proving to them my sincere interest in Chinese people and society. By that time the process of mutual adjustment on the part of myself and the Chinese had progressed to the point where we could exchange viewpoints and understanding. More Americans are successful at this exchange and acceptance than the British because Americans accept the Chinese as equals, while most British view the Chinese as inferiors and live in their own isolated world. However, many Americans display this same arrogance. Once the trust and confidence of the students is won, insights are opened to the Western in great number; there is, therefore, much basis for mutual experiences between Chinese and Americans, given patience on both sides.

Another Year of Service

Dear Brothers in Chi Phi:

The Chi Phi Educational Trust has just completed another year of service to American Higher Education. This letter contains the story of the growth of the fund and the manner in which the scholarship awards and school loans were made, and details the scholarship awards and student loans granted during the year.

I would like to take this opportunity to personally thank each contributor and loyal worker for his splendid response and effort on behalf of the Trust.

Accompanying this letter is a Balance Sheet and Income Statement for the year ending July 31, 1967. The following remarks are intended to amplify the report.

Scholarship Awards:

Ten scholarships were awarded to students during the 1966-67 academic year. Iota (Ohio State), Alpha Chi (Ohio Wesleyan) and Tau Delta (University of Oregon) received the annual awards presented to the chapter ranking highest among all chapters, and for the greatest improvement in scholarship.

Student Loans:

Seventeen student loans, totaling \$4,405.00 were granted during the academic year. The student's Notes Receivable Account is \$9,153.95.

Growth of Fund:

The assets of the fund on July 31, 1967 were \$202,112.73, an increase of \$18,735.98 in twelve months. The number of donors has increased steadily over the past five years and many alumni regularly include a gift to the Trust in their annual giving program. A substantial

number of pledges were received by the Trust in 1966 and 1967 with payment due over a three year period. New contributions, in addition to payments on pledges, insures the continued growth of the fund at about 10% a year.

Investments:

The Trust's major investments are in mortgage and secured loans to Chapter House Associations. During the year new loans were made to the following: Tulane University Colony, Rho Iota Kappa (University of Rhode Island), and Alpha Delta (Penn State). A loan commitment was granted to Zeta (Franklin and Marshall) for October, 1967. The Gamma (Emory) and Eta Delta (U.S.C.) chapters retired their outstanding notes.

A number of gifts of common stock were received by the Trust and were added to the portfolio. No stocks were disposed of during the year.

It has been very gratifying to me to note the increasing number of brothers who have included a bequest to the Trust in their Will. It is my hope that you will consider adding a codicil to your Will including the Trust as one of your beneficiaries. Your Trustees are able and most conscientious and I wish to thank them for their continued contribution of time and thought to the administration of the fund which has become so essential to the overall well being of the Chi Phi Fraternity.

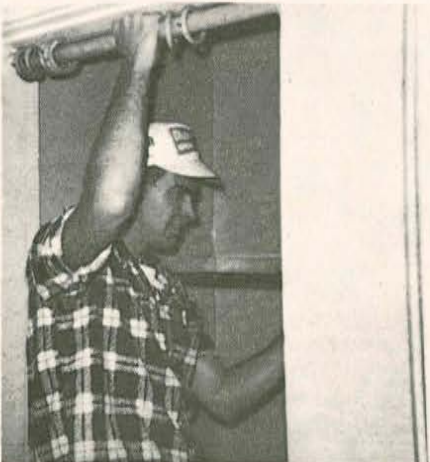

The Colony hopes to pledge ten to fifteen men at that time.

Miami University, founded in 1809, is located about 30 miles northwest of Cincinnati near the Indiana-Ohio state line. Miami University is known to most fraternity men as the birthplace of the Miami Triad, Sigma Chi, Beta Theta Pi, and Phi Delta Theta were founded there prior to the Civil War. Phi Kappa Tau was founded at Miami in 1906. All of the above names have their central headquarters adjacent to the Miami campus in Oxford.

The University has grown steadily in recent years. About 10,000 men and women are presently enrolled. Advance degrees are offered in many fields.

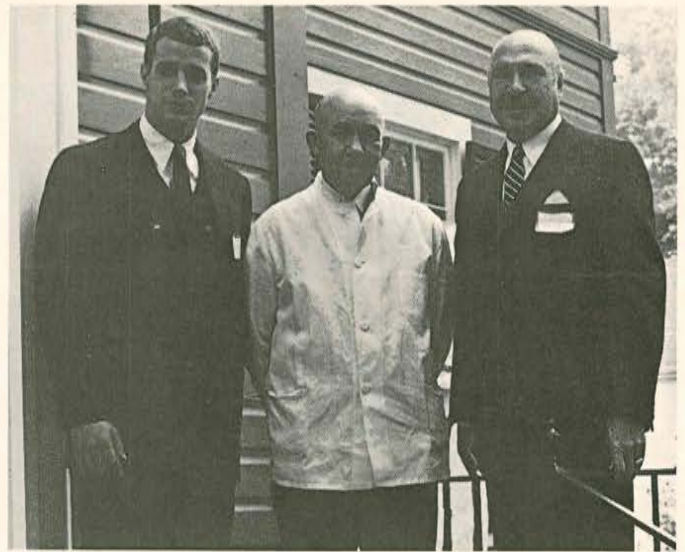

Breakfast at Northwestern

IT IS 5:30 A.M. A door creaks open in the basement and a hunched-up, bleary-eyed figure stumbles forth. It shuffles into the kitchen and turns on the lights, wincing at the sudden brightness. An unsuspecting toe collides with a table leg and a muffled oath escapes from a hoarse throat.

The Chief is ready for another day.

The Chief (his real name, not generally known, is Juan de la Cruz Simplicio Pajardo de Leon Rodriguez Moncardo Jr. de Gomez Baytan) stands a shade over five feet tall. His seamed, leathery face bears testimony to his 58 years of age and 30 years in the Navy. It is a face usually given to expressions of dour pessimism, although it has its moments of humor. The body, even though weighted down with years, possesses some mysterious vitality giving it youthful animation and co-ordination.

The Chief ("call for short Ben") is always clothed in the same pair of baggy, nondescript brown trousers. They, like the man, are seemingly indestructible. An open-necked sports shirt of atrocious hue adorns his torso. For his duties as fraternity cook, he dons a long apron and a white cap. The cap gives him the ludicrous appearance of an el-

derly Filipino angel as its halo of white surrounnds his straight thatch of black hair.

At about 6:45, a few hardy souls straggle downstairs for breakfast. By this time, the Chief has worked his early morning wizardry. The red light on the percolator is winking, showing that the coffee is ready. A huge slab of bacon is sizzling on the stove. Dishes and bowls of batter stand ready to blossom into pancakes, waffles, and French toast. The whole kitchen sends forth its tentacles of aroma to snare passers-by.

As each individual approaches the Chief with his request, the Chief fires back a barrage of words calculated to prod him into wakefulness. The Chief is usually successful in this, the effect of his conversation is similar to being beat over the head with a wet sandbag. The Chief has achieved a degree of butchery of the English language that few others can hope to equal.

"What you wan', Podolotchky? (Podliska) Arrrrre you wettin' for Chreemus? How do you dooo, Cardwell? (Buchwald) Thass my boy. Hurry up, we serve 'em up speciale, you know, allatime servemup speciale. GAW-

DAHM Wictess (Witek), you gotta be onna ball, you know."

The barrage is accompanied by a pantomimist's repertoire of grimaces and gestures. Because of this, breakfast is often likened to a meal with a floor show. The Chief is no mere clown, however. As the day wears on, he will lend a sympathetic ear to complaints about classes, girls and other problems. He is called upon to serve as human relations counselor, father confessor, and resident psychiatrist. Even if his advice is not always pertinent or cogent, it is entertaining. He is a fine listener, a master of this neglected art.

The day wears on, with its minor crisis of lunch and dinner. We assure ourselves of continued well-being as long as the Chief ministers to the needs of our stomachs and souls. The evening arrives; the Chief has earned his repose. He relaxes over a dish of ice cream. He relaxes us with accounts of his movie-making days and the time he spent cooking for the Admiral of the Sixth Fleet. For all his occasional peevishness and crankiness, he is still very good company. He is a very human being.—*The Pi Reporter.*
