# LET'S TALK IT OVER...

## "LOOK FORWARD"

THE 1968 CONGRESS is not yet history for one of the actions recommended by Congress was the establishment of an "ad hoc" committee. The committee to consist of undergraduates and alumni and called "Look forward." The title is descriptive of the purpose. The Council has the matter under advisement and will consider the recommendation at their next meeting.

## REGIONAL COUNSELORS

THE FRATERNITY SYSTEM daily faces new challenges. School administrations establish new and further restrictive rules. Faculties charge fraternities with being anti-intellectual and antiquated. Some militant student organizations are attempting to discredit our purpose and role in college life. Our own chapters appear at times to lose touch with the essence of our purpose and frequently bring discredit to the system through indifference to good taste and lack of judgment.

Sensing a need for more frequent contact with and between the chapters, and more assistance from Council, a new organization has been established within the fraternity's Constitutional organization. It will be known as the *Regional Counselor* program.

Fourteen regions have been established. A representative of the Council to be known as *Regional Counselor* will be appointed by the Grand Alpha to serve in each region. He will be responsible for the chapter, colonies and alumni organizations within his district.

The Regional Counselor will visit each chapter at least twice a year, preferably once in the fall and again in the spring. He will reside in the region which he supervises, and of course, will be available for consultation and advice between visits. The National Director and staff will continue to visit all chapters regularly.

A number of Counselors have been appointed and are functioning. However, there are still several openings for Counselors. The Grand Alpha would welcome inquiries or recommendations from alumni living in the regions which have no Counselors.

# Congratulations!

## William Saxbe Elected United States Senator

WILLIAM B. SAXBE has been Attorney General of the State of Ohio for eight years, longer than any other man in history. He was elected to the Ohio House of Representatives four times beginning in 1947. He was elected Attorney General in 1956, 1962 and 1966. On Nov. 5, 1968, he was elected to a six year term in the Senate. He will sit on the Republican side, the first Republican to represent his party from Ohio in 14 years.

Brother Saxbe has retained a close identification with Chi Phi. The delegates to the 1962 Congress in Cincinnati will recall Brother Saxbe's address delivered at the awards luncheon. While serving in the Ohio House of Representatives he found time to serve as Iota's alumni advisor.

Saxbe conducted a long and hard hitting campaign to defeat John J. Gilligan who had won out over Senator Frank J. Lausche in the Democratic primary. Saxbe's wife campaigned equally hard, buzzing through the State to garner votes from May to November. Son, Rocky took two weeks off from his studies at Southern Methodist University to help his Dad during the closing two weeks of the campaign.

Saxbe's record while in the Ohio House is indicative of his aptitude for leadership. He was majority leader of the 99th General Assembly, Speaker of the House of the 100th General Assembly, Chairman of the Ohio Program Commission in 1953, Vice Chairman of the Ohio

Legislative Service Commission in 1954, and a member of the Ohio Un-American Activities Commission in 1953-54. As Attorney General, he was Chairman of the Ohio Crime Commission, which he conceived.

As Attorney General, Bill Saxbe has been involved with nearly every aspect of Ohio government. As Ohio's legal advisor and legal defender, he has been closely

BROTHERS CHARLES R. JONAS, Alpha-Alpha '25, William E. Minshall, Alpha '36, John P. Saylor, Zeta '29, and Vernon W. Thomson, Kappa '27 were reelected members of Congress in the November 5th elections.

Jonas, a Charter Member of Alpha-Alpha, serves the 9th Congressional district of North Carolina. He was first elected to Congress in 1953.

Minshall was elected to the 84th Congress in 1954. He resides in the Cleveland, Ohio area and serves the

23rd district.

Saylor lives in and represents the Johnstown, Pennsylvania district. Brother Saylor was elected to Congress in 1951 and is therefore the senior of the group in length of service.

Thomson, past Governor of Wisconsin, serves the 3rd District of Wisconsin. He is the junior member of the group having been elected to his first term in 1961. He resides in McLean, Virginia.

IN THE SPRING SEMESTER of 1968, three Chi Phi's, doing their graduate work at West Virginia University, got together to discuss the possibility of establishing a Chi Phi Colony on this campus. Their names were Dr. Miles Crowder (Gamma), Frank Bialon (Delta Xi), and William Martin (Delta Xi).

After appraising the situation and deciding that West Virginia University was both ready and lucrative for the formulation of a new Greek organization, they contacted the National Director, and approached him with the idea. The Council gave the three men permission to attempt to get a Colony going but explained to them that it was financially unfeasible at that time to offer more than minimum support since the Fraternity's expansion program was virtually at capacity.

Miles, Frank and Bill set to work to see what could be done. They petitioned the Interfraternity Council for permission to begin founding their Colony and since the IFC was very anxious to see some additions to the established set of Greek organizations on campus, the approval was granted. All the Greeks were most helpful in trying to make it easy for the Three to start the first new fraternal organization at West Virginia University in seventeen years.

### Early Success

NOW THE WORK really started for them. Rushing out of the student union, in the middle of the semester, with very few leads, the Three proceeded to interview some one hundred and twenty-eight interested men. After much deliberation and cautious selectivity, they narrowed the number down to seventeen choices of which sixteen accepted bids to become West Virginia University's first

Chi Phi pledges. The first sixteen were: Edward Greenwald, Scott Parker, Douglas Crossan, Jerry Kranak, James McMullen, A. R. Yost, Fred Sirbough, Raymond Schulz, David Butler, M. F. Dunbar, James Crum, Joseph Lawson, Robert Thomas, David Nicholas, Richard Miller, and George Preikszaits.

Not wishing to waste any time, the Sixteen set down a program to be followed in the coming fall semester and set out over the summer to secure housing for the men.

The Sixteen faced their first crisis when they found out that Miles, Frank, and Bill would be leaving to continue their schooling elsewhere. This meant, that as a group, the Sixteen were a ship without a rudder. After discussing the matter with Mr. Gladfelter and the campus IFC, it was decided that some of the pledges would have to be activated before leaving for the summer so that it would be possible to save some foundation from which to build in the fall. Six were chosen to activate at the Delta Xi chapter at West Virginia Wesleyan. These first six actives were: Scott Parker, A. R. Yost, Ed Greenwald,



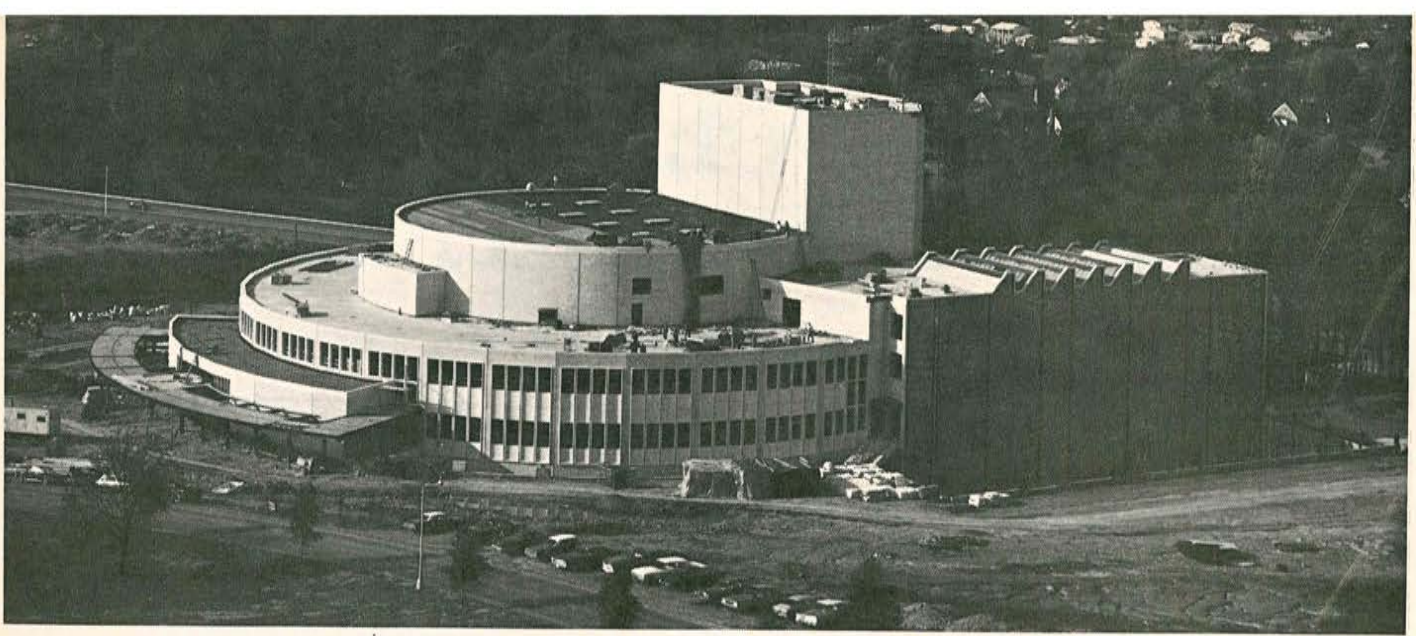

Ray Schultz, Robert Thomas, and David Butler, in the order of their activation.

At the first official meeting of the Colony, on June 15, 1968, the Colony elected their officers with Ed Greenwald presiding as Alpha, Robert Thomas as Beta, David Butler as Gamma, David Nicholas as Delta and Scott Parker as Zeta.

### House Rented

Madigan Ave. address. The search for permanent and larger quarters is now under way. Returning to West Virginia in September, the members put themselves to the task of a very competitive rush. With some fifty men going through upper-classmen rush, the six actives and ten pledge bid seven men who they felt could live up to the ideals of Chi Phi. Of these seven, six accepted their bids. Now we stand twenty-two strong; and with the aid of our advisor, Dr. William H. Marshall, Alpha-Chi '53, and the good name of Chi Phi, we are ready to hold our own as a fraternal organization on this campus.

### *University Centennial Celebrated in '67*

WEST VIRGINIA University, founded February 7, 1867, celebrated its centennial year at a time of growth of its student body, faculties and staff, expansion of physical plant, and redirection and reform of its objectives and programs unprecedented in its history.

West Virginia University combines in a single institution the functions of a state and of a state land-grant university—functions commonly assigned to two or more institutions in other state settings. Hence, the range and variety of instructional, research, and service programs at West Virginia University is greater than that of most institutions its size. The primary mission of the University within the West Virginia system of higher education is to serve as the major center of professional and graduate training and research in the State. The rapid movement of the University in this direction is reflected in the fact that, during the decade 1954-55 to 1964-65, University undergraduate enrollment rose by one-half while graduate and professional school enrollments more than doubled.

### *History of University*

THE UNIVERSITY had its origin in the Morrill Act of July 2, 1862, and in an act of the 1863 State legislature accepting the provisions of that act.

On January 9, 1866, trustees of the Monongalia Academy in Morgantown offered the State all of its property, including the site of Woodburn Female Seminary, on condition that the new institution be located there.

The offer was accepted and on February 7, 1867, the Agricultural College of West Virginia was established. The following year, President Alexander Martin succeeded in persuading the legislature to change the name of the institution to West Virginia University.

During the institution's early years, its supporters were divided on whether it should be a "state-supported university" or a "first-class state-supported college." The university concept won out in 1895, when President James L. Goodknight organized a College of Engineering and Mechanic Arts, a College of Arts and Sciences, a College of Law, and a College of Agriculture.

The major academic divisions of the University today are: the College of Agriculture and Forestry; the College of Arts and Sciences; the College of Commerce; the Creative Arts Center; the School of Dentistry; the College of Engineering; the Graduate School; the College of Human Resources and Education; the School of Journalism; the College of Law; the School of Medicine; the Division of Military Science and the Division of Air Force Aerospace Studies; the School of Mines; the School of Nursing; the School of Pharmacy; and the School of Physical Education.

### *'Phi Psi' The First*

FRATERNITIES first appeared on the West Virginia campus in 1890 when Phi Kappa Psi established a chapter. Sigma Chi followed in 1895. Both fraternities still flourish and in addition there are eighteen others including: Alpha Gamma Rho, Alpha Phi Delta, Alpha Sigma Phi, Beta Theta Pi, Delta Tau Delta, Kappa Alpha Order, Kappa Sigma, Lambda Chi Alpha, Phi Delta Theta, Phi Kappa Sigma, Phi Sigma Delta, Phi Sigma Kappa, Pi Kappa Alpha, Sigma Nu, Sigma Phi Epsilon, Tau Kappa Epsilon, Theta Chi, Lambda Chi Alpha.

Lambda Chi Alpha, established in 1951 was the last fraternity, thus Chi Phi makes the first fraternity in 17 years to enter the campus.

### *Two Chapters In State*

THE BROTHERS OF Delta Xi, West Virginia Wesleyan have been most helpful to the new Colony, and Chi Phi looks forward to the rapid development of a strong alumni group in the state now that a second chapter is soon to come into existence.

## *Student Loans*

OVER FIFTY Chi Phi undergraduate and graduate students have borrowed much needed funds during the last two years. The loans are repaid with interest. There has been only one uncollected loan of \$250.00, in 8 years.

J. Douglas Wallace, Alpha Delta '68 repaid a loan in October and said "It helped to pull me through my final year at Penn State and thus complete my undergraduate education. I hope that in the future I will be able to contribute to the Chi Phi Educational Trust and thus help others to complete their education."

## *Scholarships*

A SMALL scholarship can sometimes be the difference between an orderly education and a long delay or break for a student who must earn funds to continue in school. This past year nine scholarships were awarded to Chi Phis. The previous year, six awards were granted.

James C. Parker, Tau '62, now an admissions officer at Auburn University wrote the following letter in 1966, expressing his thanks: "I appreciate all that the fraternity and Trust have done for me and only hope that the results at Auburn will justify its generosity. I am now in graduate school and taking a normal load."

## *Reference Library For Each Chapter*

WHEN THE "For the Future—\$500,000" fund drive was instituted several years ago, one of the promised programs was a good reference li-

brary in every chapter. In October 1968 each chapter received a Random House Dictionary of the English Language-Unabridged Edition. A Roget's Thesaurus will be presented to every chapter in November, with a third volume to be delivered early in 1969. Present income from the Trust will provide about three books per chapter per year.

### Study and Library Facilities for Selected Chapters

A NUMBER of chapters have been granted funds to improve existing libraries or add library and study facilities.

The West Virginia Wesleyan chapter added a study room on the third floor at a cost of \$200.00. Alpha Theta Chi at Nebraska, received a gift of \$500.00 to help furnish the library in a new house. Tau at the University of Alabama will be the recipient of \$1,000.00 library appropriation as soon as they break ground for their new chapter house. Alpha-Chi is receiving \$500.00 towards their new library which is currently under construction.

### Houses and Improvements for New and Old Chapters

THE UNSEEN VALUE of a gift to the Trust lies in the investment program. A major portion of new funds are invested in first and second mortgages on chapter houses, thereby providing important and sometimes unobtainable funds for new chapter houses and the improvement of existing houses.

The Chi Phi Club of Cincinnati was able to provide a house, during this past summer, for the Miami University Colony, with the proceeds of a loan from the Trust. The Valley Association accomplished the same goal with a loan from the Trust to purchase a house for the University of California-Davis Colony in Davis, California.

Other chapters receiving loans in recent years are: Zeta, for an addition to the house; Nu, for the construction of their now 10 year old house; Iota Delta, Indiana University and Lambda Delta, University of Arizona.

### Leadership Development

THIS PAST SUMMER a grant of \$500.00 made it possible to conduct a two day Leadership Seminar for chapter officers and leaders at Cornell University, Ithaca, New York. The program was directed by W. Dan Fitzpatrick, Xi '59, Director of Student Activities, University of Michigan. The instructor was Prof. David A. Potter of the University of Delaware.

The Trust has succeeded in touching the lives of many Chi Phi stu-

dents. Lack of funds minimizes the total effort, however, for it is necessary to "turn down" some requests for loans, and limit the number of scholarship awards to a select few. Requests for building loans from chapters are pending and will be delayed until additional funds have been contributed and become available for investment in mortgages.

The trustees appreciate the many contributions received during the past three years from the many loyal alumni, that have made the programs described possible. # "Cleveland Airlift"

Directs Helicopter  
Operation*

"ALL EYES turned skyward as a helicopter hummed in over the rim of the Cuyahoga River valley and hovered effortlessly over the new 84-inch cold strip rolling mill which is rapidly taking shape at the Cleveland District steel plant.

Slung beneath the "chopper" was a 700-pound section of the roof ventilating system for the annealing area of the mill. On the roof, workmen employed by an outside contractor eased the section into place, the huge rotors signaled a windy farewell and the big bird headed for the pickup point a mile and a half away. Time for the round trip: under three minutes!

Under the watchful eye of chief pilot John Dodge of Minit-Men Inc. of Columbus, Ohio, the helicopter breezed through some 200 round trips in approximately nine hours. Had the ventilator sections been trucked from the fabricating site to the new mill and put in place by mobile cranes, the job would have taken at least a week."

The above story appeared in the February 1968 issue of "Republic Reports"—the Republic Steel magazine. The president of Minit-Men Inc. is Charles W. Thomas, Iota '54. Brother Thomas served in the U.S. Air Force as a jet pilot during the Korean war.

At the present time he has a hangar of four helicopters, a fleet of tanker trucks to carry various types of agricultural and weed control chemicals, as well as fuels for on the location refueling operations. The company maintains power line right of ways, does agricultural fertilizing and spraying, lifts light standards and poles into position, strings power lines and generally aids the construction industry as illustrated in the accompanying picture. Aerial mapping and photography is routine. According to the youthful and aggressive president "there are new opportunities and jobs arising everyday for his company, which is located in a modern new

facility in Columbus, Ohio.

## People to the Polls—Nebraska Chapter Serves in Election

IN THE SPRING of 1965, Brother Walt Radcliffe, then a pledge and now Alpha of Alpha Theta Chi Chapter, organized a community service project that has proved very successful for us. He conceived the idea of transporting disabled voters to the polls on election day and it has been carried on ever since. The Brothers and Pledges of Alpha Theta have taken on "People to the Polls" as an annual event, whenever there is an election in Lincoln, Nebraska. The Brothers feel that exercising the right to vote is important and that many elderly or disabled persons would like to do so if they could, and we have tried to help them through the project. We have done this for every election since 1965, national or local. This could be expanded to a national Chi Phi service project.

This election year was an especially good one for us for two reasons, first because of the importance of the Presidential election, and secondly it was a rainy, dreary day. We transported well over 100 disabled or elderly persons to the polls, although we will take anyone who calls us. One of the highlights of this year's project was taking a pretty coed to the polls at the last minute after her car had broken down two miles

from her polling place.

We started organizing the project approximately a month ago. The local radio stations were very willing and played thirty second spots for us advertising the project. Newspapers carried free ads, and one local television station gave us a spot on their "Morning Show" on election day. Anyone wanting a ride to the polls was urged to call the Chi Phi House, or either of the political party headquarters. The information was then relayed to a central desk in the Chi Phi living room. From there the times that the people preferred to be picked up were put on a chart and drivers dispatched at the proper time.

We carried blind persons to the polls, had election commissioners come to cars so that disabled persons could vote, and even took a commissioner to a disabled person's home. The biggest delight of the day was transporting Mrs. Sophie Page to the polls. Her family has voted and not missed an election for as long as she can remember and she herself has voted in every election since women's suffrage was voted in. It is also interesting that Mrs. Page is the grandmother of Kent Gerlach, Alpha Theta '66. Kent says "My grandmother is well over 65, but still urges us all very strongly to exercise our privilege to vote and does so herself." We were very well pleased with the cooperation we received from the local news media and the number of people that we helped to vote.

## The Clarks of Eta and Omega

SCHUYLER W. CLARK, Omega and Eta '33, is in the middle of a long line of Chi Phi's. His two sons, Schuyler W., Jr. and Thomas B., attended Tech and are members of Omega. His father, Frank R., Jr. was a member of Eta and graduated in 1904, and his grandfather, Frank R. Clark, who started the whole process, was initiated into Eta in 1872. Schuyler W's older brother, Frank R. Clark, III, Omega '27 resides in Atlanta and of course is the Uncle of the two younger family members of Chi Phi. The Clarks were born in Augusta, Georgia, although Schuyler W., Omega '61 now resides in Atlanta and Lt.



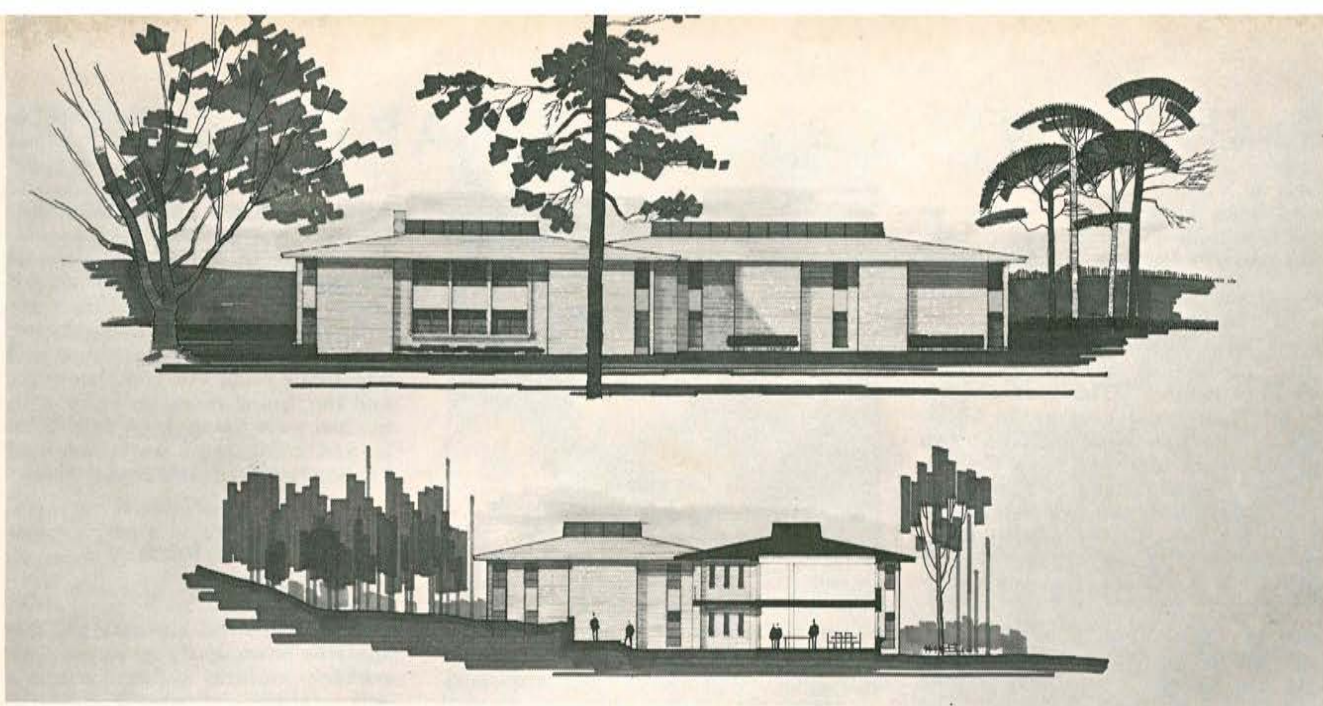

## Theta Delta Breaks Ground for New Home

A GROUND-BREAKING on the beautifully wooded lot—largest on fraternity row—was a feature of Homecoming at the University of Florida on Nov. 2nd.

Circuit Judge James D. Bruton, Jr., of Tampa, ThD '31, officiated with the shovel, and the Rev. Johnson H. Pace, ThD '40, Grand Beta and Rector of Holy Cross Episcopal Church, Jacksonville, spoke briefly and offered a prayer.

Others participating were: Ralph Hollister, ThD '44, Winter Haven, paper company executive and outgoing president of the Florida Chi Phi Association, Inc.; Bob Wattles, ThD '69, Orlando-Chapter Alpha; Joel Sayers, ThD '43, Daytona Beach, architect with the firm of Greening and Sayers; and Mrs. Dorothy Langdon, the fraternity's house mother.

Sayers unveiled plans for the new house at a meeting of the Association preceding the ground-breaking. Plans are to let the contract about Feb. 1, 1969, and to occupy the new house prior to the start of the 1969-70 school year.

Sleeping accommodations for 44 men will be provided. The new location is nearest to the freshmen dormitories—a lot that other fraternities passed up because a drainage problem will cause additional expense. The lot is one of two on fraternity row which have not been improved, and is next door to the lot Chi Phi originally bought back in 1948 and later sold back to the University when the present house was bought in 1952. SAE now occupies this lot.

The new house will be arranged in suites of three rooms, so that actives may sleep three to a room and use the center room of the suite for study, or if they prefer utilize all three rooms as combination sleeping-study rooms for two. Construction cost was esti-

mated by Sayers at \$233,000.

To date, 140 alumni of Theta Delta and other chapters have contributed or pledged \$96,000 to the New House Campaign. Almost half of these funds have been collected, and a strong effort is underway to secure as much of the remaining pledges as possible prior to letting the contract.

The fund raising, sale of the present property, and construction is in the hands of a Committee of the Board of Directors of the Florida Chi Phi Association, Inc., consisting of A. R. Updike, Jr., ThD '43, Lake Wales citrus man and incoming president; Gray C. Ramsaur, ThD '39, Jacksonville attorney; Bob Cody, ThD '40, Kissimmee publisher, together with Hollister, Sayers and Pace.

Finance is being handled by a special

committee composed of Updike and Ramsaur, plus two Miami alumni—Paul L. E. Helliwell, attorney, and Thomas F. Fleming, Jr., banker.

Gifts made for special purposes to date include: \$7500 from the Fleming family—Tom, Jr., ThD '38, John '41 and Foy '43—for the chapter room in memory of their father, Tom, Sr., an alumnus of Gamma chapter at Emory University. \$6,000 from Arch Updike and his brother, John, ThD '45, for the dining room. The living room will be dedicated to Alpha Delta local fraternity which was Chi Phi's predecessor at Gainesville.

Gifts are still being sought for the Library (\$5,000), Housemother's suite (\$5,000), and for 10 of the study-sleeping rooms at \$2500 each.

In addition to the amount already pledged, approximately \$28,000 more will be needed to complete furnishing the new house.

## New Chapter Installation December 7

CHI PHIS from throughout the state of Florida were invited to participate in the installation of Xi Delta chapter at Florida Institute of Technology at Melbourne on Dec. 7.

Grand Alpha Joseph R. Dockery was expected to formally present the charter to Paul S. Keller, Alpha of the chapter. Other grand officers expected are the Rev. Johnson Hagood Pace, grand beta, Richard Ham, grand gamma, and Carl Glatfelter, national director.

Xi Delta chapter is located at 908 Strawbridge Ave., in Melbourne, but the installation banquet and dinner dance has been planned for the F.I.T. Student Union Building.

Robert N. Rokobauer, Zeta of the chapter, was asked to present a historical sketch of the colony, and Richard G. Simmons, ThD '51, was asked to

serve as toastmaster.

## Mu

### Stevens Institute of Technology

MU CHAPTER is situated on the campus of Stevens Institute of Technology in Hoboken, N.J. On October 18, 1968 we were 85 years old. It was just thirteen years after the founding of "The Old Stone Mill" as Stevens is known, that a small group of students under the leadership of Edward Lithcum Dent petitioned the Chi Phi Fraternity for a charter.

At the turn of the century the Mu brothers occupied a house at 1022 Garden Street, half a mile from the campus. With an eye always open for a better location, they made many moves until they found the house on Hudson Street—one block from the Institute. The advent of the war in Europe unexpectedly threw on the market a fine house, at the corner of the Athletic Field, owned by a German architect. With the help of several faithful alumni and a large mortgage, the brothers were able to buy the house known as "Green Gate" which we still occupy at 801 Hudson Street.

"Green Gate" is a sturdy structure—just what is needed for a fraternity house. It is fireproof, being constructed of brick, steel, and concrete—even in the interior walls and floors. On the first floor there are a library, living room, dining room, and kitchen. Both the second and third floor have four large rooms and bath, accommodating 20 men. Two small rooms and bath, together with a sundeck, on the fourth floor comprise the coveted "penthouse." Our unique system for financing room improvements assures the high quality of the furnishings. There are 31 brothers and 3 pledges at Mu. Our financial condition is unquestionable.

The Mu Alumni Association owns the chapter house. In 1944, the chapter, with the generous help of the Mu Alumni Association was able to pay off its mortgage and held a well attended mortgage cremation banquet in N.Y. Twice a year the Mu Alumni Association has its meeting at the chapter house, but younger members return to the house more frequently to enjoy the social functions.

Now that we've taken you for a little trip into the past to view the history of Mu Chapter, you will want to know something of Mu at the present. Chi Phi at Stevens is one of ten national fraternities on campus and is thus a member of the Interfraternity Council.

We rank third in overall scholarship and participate in all I.F.C. sponsored events and functions. At present, the college is attempting to place the fraternities in a "Quadrangle" type structure. The fraternities are generally split on this subject and any further developments will be forthcoming.

Many of the brothers of Mu are very active in campus activities and hold prominent positions. Among these are President and Treasurer of the Junior Class; Editor, Business Manager, and Circulation Manager of a campus magazine; Treasurer of the Student Council; Vice President of the I.F.C. and officers in various clubs. Other activities which brothers are involved in are Air Force ROTC, Honor Board, Glee Club, five teams, and several religious organizations. Many of our brothers are on scholarship grants and several are members of honorary societies such as Tau Beta Pi, and engineering fraternity; Pi Delta Epsilon, a publications fraternity; and the Arnold Air Society. The I.F.C. is presently coordinating a P.A.L. athletic program for local youngsters in which athletic equipment, clothing, and coaching will be offered. The ten fraternities share the time and expense equally. Well, we hope you've enjoyed reading about Mu Chapter at Stevens. We at Green Gate, after 85 years, take great pride in our fraternity and the men who make this organization a true brotherhood. —Andrew W. Kalamaridis, Zeta
