## SITUATION AT DARTMOUTH

A NUMBER of Chi (Dartmouth) members have expressed disgust, regret and bitterness over the loss of the chapter. Many have stated their disapproval of the Chi Association decision to rent the chapter house at Hanover to the local fraternity which succeeded Chi. They are of the opinion that the house should be sold and the proceeds turned over to the Chi Phi Educational Trust. Two Chi alumni have expressed their feelings on the Chi matter in letters to the Editor of the Dartmouth alumni magazine. One letter appeared in the December 1968 issue, the other will appear in the forthcoming March 1969 issue.

Incidentally no Chi alumni have been removed from the Fraternity roll by any action of the Council. All are members in good standing regardless of the fact that the Chi charter has been suspended.

# The Story of The Badge



*From the chronicles of Chi Phi, by Dr. Theodore B. Appel, Zeta '89, Grand Gamma '06-'12, Grand Alpha '13-'23, Grand Epsilon '23-'37, published by The Chi Phi Fraternity in 1939. It chronicles the history of Chi Phi, and gives permanent life to the men who have given many of their business hours, and most of their leisure to the Fraternity. The Chronicles are now out of print.*

IN THE ARCHIVES of the Fraternity there is a small collection of Chi Phi badges, very different from the badge we wear today, but each representing an era in the development of the Fraternity. These badges were collected mainly through the efforts of the late Dr. Theodore B. Appel, and many were given to him personally. Shortly before his death he placed them in our archives so that the Fraternity would always have these material symbols of our historic past.

As we pick up these badges, we cannot but feel that the mist that always shrouds history is cleared a bit, and the Princeton, Southern and Hobart Orders become a little more real. On closer examination we can see portrayed the various unions through which the Fraternity has gone. And, finally, in our present badge we see exemplified, through the erasure of the symbols of the various Orders, the strongly united National Organization of today.

The first badge worn by Chi Phis was the original badge of the Princeton Order. This was probably the Princeton Order of 1854. It was a plain gold monogram badge, the "Chi" on top of the "Phi." There was no provision in the constitution or by-laws that the badge be a monogram, yet this was the form in which the

badge was invariably made. Later the badge was embellished so that on the "Chi" were engraved a skull and crossed bones on the narrow bar (the skull at the top of the bar and the crossed bones at the bottom), and two daggers (with points toward the center of the pin) on the broad bar. The half circles of the "Phi" were engraved with a grapevine. These badges varied greatly in size.

The badge of the Southern Order was jewelled, mounted with rubies and pearls. On the top bar of the "Phi" was engraved crossed swords, and on the bottom bar clasped hands. On each half circle of the "Phi" was engraved a star. A skull and crossed bones were also engraved on the badge as well as the four Greek Letters "Epsilon," "Kappa," "Phi," and "Delta." These were the initials of the secret motto. In fact all the above symbols had a very definite significance explained in the constitution of the Order. A guard pin in the shape of a small shield was worn.

The Hobart Order had a more elaborate badge. The type was definitely described in the constitution of the Order. However, the description was not closely adhered to with the result that badges differed extensively as to size and detail. The description of the badge, taken from the constitution of the Hobart Order is as follows:

"The Badge of the Fraternity shall be made of Gold, at least 16 Carat fine, set with at least three stones, a large one at the junction of the two bars of the Chi and two smaller ones at each end of the Bar of the Phi. The colors shall be scarlet and blue, the scarlet on the narrow and the blue on the broad bar of the Chi, and they shall ever be preserved as the colors of the Fraternity.

"The Badge shall be a skeleton Badge, the Chi over the Phi.

"Upon the guard pin of the Badge shall be placed the initial letter of the Greek motto adopted by each Chapter, though in no case shall the initial letter be the same as that of another Chapter."

At the Union of the Princeton and Hobart Orders to form the Northern Order, a comparison of the constitution and rituals of the Orders disclosed the great superiority of those of the Hobart Order, so that they were adopted practically unchanged. With this adoption went the badge.

However, this was not the case later when attempts were first made to effect the union of the Northern and Southern Orders. At first each Order desired that its badge be adopted in toto. But on May 2, 1873, at a meeting of the committees representing the Northern and Southern Orders it was decided that "the badge of the Fraternity shall be a skeleton badge, the CHI over the PHI. The colors upon the same, scarlet and blue; the scarlet upon the narrow, the blue upon the broad bar of the CHI; its emblems shall be two Stars, Crossed Swords and clasped hands, all of which shall be upon the PHI." At the first Convention of the Fraternity after the Union, held in Washington, July 23, 1874, the constitution was so amended that the badge of the United Order was changed to have "upon the bar of the Phi at the top, Crossed Swords; at the bottom clasped hands; and upon each half circle of the Phi, a star; all cut into the gold."

During the early period of the United Fraternity it was great sport at the successive Conventions to amend the constitution. And so it was not long until the badge became a victim. In fact at the Convention in Richmond, Virginia, April 27, 1875, the crossed swords and clasped hands were removed from the badge and later, at the Washington Convention, October 9, 1884, the star on each half circle of the "Phi" was removed. These changes appear insignificant to us today, but indeed they typified the unrest, the feeling of sectionalism, and the weakness of the national organization present in the Fraternity at that period. These internal weaknesses and controversies were finally brought to a crisis in 1895 when the controversy over the Kappa (Brown University) Chapter was brought to a head. During the few preceding years these weaknesses were very apparent, and the solution was arrived at that year by the adoption of a strong constitution granting great central powers to the Grand Lodge. The new constitution wisely designed a new badge which was neither Northern nor Southern Order, but more like the Original Princeton badge. It was not jewelled but enameled and its symbols were those on the Princeton Badge, the grape vine. Furthermore, the badge was patented and made the standard and only badge of the Fraternity. The size was definite and since the badge was made only by an official jeweler, all badges were alike. Finally, with the exception of minor technical changes it is the badge we wear today.

So, as we put these old badges away, we feel that we, too, have taken a part in the early struggles of the development of the Fraternity. We realize as we turn to the one on our vest all that it represents and are convinced that the victories and defeats typified by the old badges have not been in vain, but have helped build a stronger and greater Fraternity. It makes us more optimistic as to the future, especially when at our present Congresses, problems and disputes arise that to us seem to have no solution. The Fraternity *will* go on, and, as the years roll by, will ever be *stronger* and *better*.



### *The National Director Says 'Perhaps' in his Report to Congress*

IN HIS ANNUAL REPORT to Congress, which was in fact no report at all, the National Director, Carl Gladfelter raised this question, "Is our Fraternity structured to meet the needs of today's male college student?"

A number of undergraduates have asked for a broader circulation of the report. Many have also requested that the recommendations be implemented. The report as delivered to the 1968 Congress held at Cornell University in commemoration of Xi's Centennial year is reproduced in its entirety here.

### *The Report*

The Message of Council contains reports and statistics indicating satisfactory growth in the two years since the Pittsburgh Congress. The chapter roll is at an all-time high with 39 chapters. We have 9 colonies, 3 or 4 of which will be granted charters in the next 9 months. The Fraternity is in sound financial condition and the Educational Trust, during the past two years, has been the recipient of gifts from many alumni. We are receiving numerous inquiries relative to the development of additional chapters. We have outstanding commitment on the part of alumni serving at all levels within the overall framework. But for a few chapters our overall condition is good.

### *A Spirit of Unrest and Challenge*

However, as we reflect on the spirit of unrest and challenge sweeping our colleges and universities, I believe that fraternities must carefully study and evaluate their position and role. Our Fraternity is serving men living and studying in academic communities which are vastly different from those attended by us who matriculated at a college before 1946. So much has been said and written about the educational revolution that it would not appear necessary to document that fact here.

The question: Is our Fraternity structured to meet the needs of today's male college student? Perhaps this

question can be answered by you assembled here today in Congress, and certainly each Congress deals with improvement and change. This Congress will chart the direction of our Fraternity for the next two years even as it elects a Grand Alpha and deals, for example, with our less than glowing scholarship record. But will this effort be enough since there is the specter of unrest and challenge abroad in the land.

## *A New Background Exists*

Consider some of the situations Chi Phi Chapters face today that are unlike anything in the past:

(1) Many students no longer place fraternity membership at the top of the list of "to be accomplished." A far greater emphasis is placed on academic achievement and the student carefully weighs the merits of fraternity membership against better grades, the opportunity to achieve graduate status, the time involvement, and the loss of individual freedom.

(2) Seniors and even juniors find the fraternity a "bore" and leave its confines for apartment living, greater personal freedom and simply to get away from the freshman-sophomore approach to "party," and the incessant demands of rush and the weekly meeting.

(3) The absence of senior leadership.

(4) The new freedoms of women in the house at all hours, the abandonment or easing of rules and regulations in such "haloed" areas as the use of alcoholic beverages and the chaperone requirement.

(5) The selection of members. Realistically many of our chapters no longer adhere to the one, two, or even three negative vote requirement. School administrators are beginning to think in terms not of the number of negative votes but rather the majority.

(6) We have many houses that were built in the '20's. They show marks of many generations of use. The facilities in many cases are no longer on a par with those provided by the school or other sources. Equity funds to provide housing for both old and new chapters, is difficult to obtain. In fact, it is just not available in many cases. The chapters at Auburn, Alabama, Arizona, Ohio State, Florida and Florida State will testify to this fact.

(7) We see some Colleges and Universities abandoning the traditional role of the "substitute parent" and supervisor. They find it far less bothersome to deal in pure education, and adopt the philosophy of "if they are old enough to attend college, they are old enough to direct their personal affairs."

(8) We observe the "new student"—less interested in accepting the role and pattern of the past, discontent with the existing social and political order. Discontent with the authoritarianism of administrators and teachers.

(9) College males are marrying earlier—they are "lost" to the fraternity in their junior and senior years—the traditional years of leadership.

(10) The conflict between "personal privilege" and "group control" grows sharper with the number of devotees of personal freedom without direct responsibility to the group on the increase.

(11) We hear demands from alumni for the Council to provide more services for the chapters, i.e., do their budgeting and accounting, and collect the receivables. Are the chapters prepared to relinquish this responsibility?

Here we have the question of more central authority versus the traditional concept of local autonomy with all the opportunity for decision making, leadership development, remaining at the local level. The alumni, of course, making this plea because of irresponsible operation by the chapter.

(12) What about size? Are the opportunities for fellowship in reverse proportion to bigger chapters?

And so it goes. Numerous other considerations can be enumerated that should cause us to perhaps do a complete study or analysis of our present stature and our future role. A committee of Atlanta alumni, without official sanction, under the leadership of Brother Jack Taylor, ZD'57, and then Assistant National Director, made such a study during the summer of 1966 and reported their recommendations to the Council just prior to the 1966 Congress. It was a good report and some of their suggestions were implemented by the 1966 Congress and Council during the past two years.

## *Let a 'Look Forward' Committee Study and Recommend*

I would like to recommend that an institution like ours must reorient itself from time to time, thereby hoping to keep its program and work relevant to the community of men and interest we profess to serve. Therefore, would it not be expedient for this Congress to establish a "Look Forward" committee, whose role it would be to study among other things:

- (a) Our purpose, goal and role.
- (b) The Constitution, by-laws and ritual.
- (c) The organization, including Congress, Council, Council office, services, and procedures.
- (d) Financial structure and fiscal program.
- (e) Growth.
- (f) Publications and communications.
- (g) The alumnus and alumni organizations.
- (h) Interfraternity relations.
- (i) Relation to academic community.

Such a committee would be of the "Ad Hoc" type and composed of perhaps five undergraduate and six graduate members, with the chairman, a graduate member, to be selected by the committee. The committee would be selected with both geographic and chapter representation. The committee would meet on a face to face basis once in 1968-69 and again in 1969-70 and report to the Council meeting in February 1970 with the report to be released and published immediately afterwards. The 1970 Congress would give consideration to implementation of the recommendations. Funds would of course have to be provided since much of the work of the committee would have to be accomplished by telephone and correspondence.

A study of the magnitude suggested would require considerable time, much energy, real commitment, and would be costly. However the results could be most beneficial and out of proportion to the cost in time, manpower, and money, as we approach the 21st Century."

## *Committee to be Appointed*

The Committee will be appointed this spring by the Grand Alpha and the Grand Alpha-elect. It will first meet this summer.

# CHI PHI:

## THE MEN WHO MAKE IT WORK

As 1968 CLOSED OUT, it was apparent that the newly created Regional Counselor program was slated for success. Established during the summer of 1968 by the Council, the program was operating in seven of the fourteen regions by mid October. By February 1969 all of the Regions will be served.

FRED JANCEWICZ graduated from M.I.T. with a Bachelor of Science Degree. As a graduate student at Cornell, he affiliated with Xi. He received the Master of Science degree (E.D. and Applied Mathematics) from Cornell. ### Success in 2 Years

The Colony was established in April 1967 under the sponsorship of the Chi Phi Club of Cincinnati. The President of the Club, Brother James W. Martin, Alpha-Chi '32 and Henry C. Peterson, Iota '38, the Colony Alumni Advisor have worked

closely with the Colony from the beginning. The Council selected Richard Wilkes, Kappa Delta '67 as the colonizer. He established residence at Miami in September 1967, and immediately became the Alpha of the small group of original members who occupied the quarters rented for them by the Chi Phi Club of Cincinnati.

During the summer of 1968 the present chapter house was purchased

and readied for occupancy. Seventeen men occupied the quarters at the beginning of this school year. For them it meant that Chi Phi was really there to stay.

The first 8 members of the Colony to be initiated journeyed to the Alpha Chi Chapter at Ohio Wesleyan for the ceremony in 1967. The next six men to join the ranks received their credentials at Iota Delta, Indiana University. This past fall and again in January, Iota Chapter, Ohio State University inducted new members. The Council deliberately planned the sequence of initiations so that the new chapter would absorb some of the tradition of each chapter they visited.

The members of the Colony are highly hopeful that all of the nearby chapters will send delegations to the chartering. They say they can and will manage overnight accommodations for all visiting undergraduate brothers, but request at least one week advance notice.

# Chi Phi at Oglethorpe University

THE SCHOLASTIC YEAR 1967-68 saw the spirited rebirth of the Chi Phi Fraternity at Oglethorpe University, Atlanta, Georgia. A chapter bearing the designation "Lambda" existed at Oglethorpe College in 1871.

The "Chronicles of Chi Phi" tell us little about the Lambda Chapter of Oglethorpe. We know that it was founded in 1871 primarily through the efforts of the Kappa chapter (now Gamma) of Emory University. Its history was brief and it made no great mark in the history of the Fraternity. In those early years a charter was granted to a petitioning group with no development or period of preparation required. The present method of requiring a Colony to develop a position of strength and maturity before granting it a charter reduces the possibility of failure later.

## Colony Sponsored by Chi Phi Club of Atlanta

THE NEW COLONY was established during the spring of 1968 under the impetus of Robert Burnette '68 and Barry Brody '69. The Colony is directly under the sponsorship of the Chi Phi Club of Atlanta. Before the Alumni Club and the Council granted the Colony recognition a number of alumni were consulted on the advisability of establishing at Oglethorpe. Among those giving approval were three Trustees of Oglethorpe: Robert L. Foreman, H'18, Chairman, John E. Oliver, H'17, and Rankin Smith, G'46. Others who approved the project were William Morgan, G'57, then president of the Chi Phi Club of Atlanta, Charles Davis, Ome'55, and Charles Nunnally, H'52 both past-presidents of the Chi Phi Club of Atlanta, E. Bates Block, G'40, Grand Eta, and

James Rasnake, H'61, current president of the Chi Phi Club of Atlanta.

The Colony now numbers 23 actives and 4 alumni. The latter were initiated with Council approval by the Gamma chapter in May 1968. They occupy lodge rooms on the campus which enables them to carry on fraternity business. The members and pledges are active in all phases of campus life. Several members are on the varsity soccer squad and three play varsity tennis. The Colony is strong politically with officers in both the sophomore and junior classes.

## Oglethorpe Prexy Endorses Colony

The President of Oglethorpe Dr. Paul K. Vonk, placed his approval on the Colony in a letter saying "It is good to have your organization on campus. I know that all the members of the Chakett Club will join with me in our common goal of helping Oglethorpe realize its tremendous potential."

## History of Oglethorpe

Oglethorpe was chartered on Dec. 21, 1835 and commenced operation at Midway, Georgia, on Jan. 1, 1838. At that time there were six faculty members and 125 students. Unable to cope with the rigors and strain of wartime life, in June of 1863, Oglethorpe ceased operations altogether until after the close of the conflict. Part of the army of General William T. Sherman during his famous march to the Sea, passed through the insti-

tution's grounds, but left the property intact.

The collapse of the Confederacy delivered a heavy blow to the school, since her endowment by 1865 had come to consist largely of Confederate notes and bonds. Yet despite the adversity of the times, the trustees resolved to renew operations and in January, 1866, Oglethorpe again opened her doors, with a student body of twenty-five and a faculty of two. In 1870 the Trustees, with Presbyterian sponsorship, concluded that further efforts toward restoring the vigor of the school, in its present location, were hopeless; they resolved, therefore, to transfer the University to Atlanta, partly because that city had recently replaced Milledgeville as the state capitol, partly because economic conditions there appeared to be more favorable. At the same time they determined to convert the institution into a real university through the addition of new schools and departments.

With a faculty of five professors in the college, six instructors in the law department, and three teachers in the University high school, the new Oglethorpe opened its doors on October 4, 1870. But the move failed to bring the anticipated success. Largely because of the severe economic dislocations following in the wake of war, Oglethorpe found herself faced with bankruptcy by the fall of 1872. Thereupon, the Synod of Georgia directed the operations be permanently discontinued.

The ensuing chapter in her history is synonymous with the name of Thornwell Jacobs, who had first come to Atlanta in 1909 to serve as executive secretary in a campaign to raise \$150,000 for Agnes Scott College. By 1912 his thinking had crystallized into a determination to reestablish Oglethorpe. His first appeal for support was to the Presbyterian Minister's Association of Atlanta; his next step was to visit one hundred and one Presbyterian churches in the east, from each of which he secured a contribution of one thousand dollars or more toward the restoration of the school as a Presbyterian institution. Appropriately enough, the first Presbyterian congregation visited had been that at Milledgeville. In all, more than half a million dollars were given or subscribed toward

the goal, about half of the sum coming from individuals and groups in the city of Atlanta itself. In such a manner did Oglethorpe re-arise. Actual operations commenced on September 20, 1916, with a freshman class of forty-eight and a faculty of four.

Throughout his tenure Dr. Jacobs (appointed president in 1915) steadfastly resisted all suggestions that accreditation for Oglethorpe be sought from any regional group.

Dr. Jacobs' opposition to accrediting agencies, as explained in his autobiography, stemmed from his belief that they insisted upon a stifling conformity to their standards, without due regard to differences in approach and objectives prevailing among diverse institutions. He further felt that all too often such agencies exist more for the benefit of their directors than for any other purpose.

In January of 1944, Dr. Phillip Weltner assumed the presidency. In rapid succession the new president discontinued the medical school, the extension education department, and the printing press operations. The existing faculty members were continued in their places until June of 1944, at which time there were about eleven faculty members and approximately thirty students. Then, during the summer of 1944 the hiring of new faculty began.

A transition has taken place at Oglethorpe College since Dr. Weltner was here. A new administration has become part of the school and has set a course of enlargement that will broaden the scope of the school's academic excellence. Five new men's dormitories were built for the fall semester of 1967, a new student union was opened for the fall semester of 1968, and a new science building and library will be built for 1970. Also a new girls dorm will be ready for occupancy in the fall of 1969.

With this new mood of progressiveness, the fraternity system has re-established. Oglethorpe College has met the demands of our changing society, but at the same time is retaining the same spirit that helped Oglethorpe survive through debt, war and strife.
