The details of the weekend are a bit fuzzy, but one Alpha-Tau was heard to say as he passed out, "You guys are incredible!"

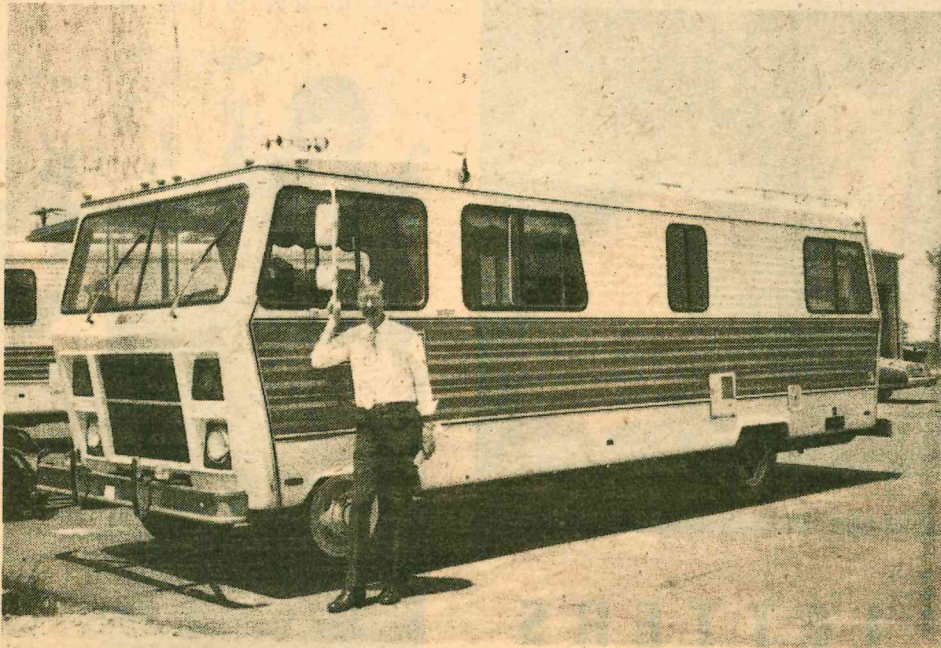
We are glad to say that the Alpha Tau's provided an excellent weekend and we hope to return the favor in the

Krannert Seminar Opens Aug. 9 in Birmingham

Planning for the 1978 Chi Phi Congress in Birmingham includes an opportunity for members of the Tau Chapter to participate in a reunion embracing a reception and the annual Congressional Banquet.

Headquarters Hotel is the Birmingham Hyatt House, but activities of the Congress will also utilize facilities of Indian Spring School and the Vestavia Country Club.

Highlight of the week will be the Congressional Banquet at 7:30 p. m., immediately following the Tau Reunion Reception at 6:15 p. m. These two events will be in the Hyatt House. A poolside party concludes the evening.

Keynote speaker for the banquet will be William Clinton Sullivan, Circuit Judge in Talladega AL, a member of Tau's Class of 1950.

Delegates will share a Tau chapter rush party at 8 o'clock Friday evening at the Country Club. The Friday afternoon program starts with a box lunch and bus trip to the school athletic field for an afternoon of sports activity, followed by a barbecue dinner.

Speakers invited for the Krannert Leadership Seminar sessions on Wednesday and Thursday include Arthur Rheinhold Uppgren, retired economist living in Boca Raton FL, and Dr. Edwin J. Phillips of Decatur AL.

Uppgren, formerly vice president and economist for the Ninth District Federal Reserve Bank in Minneapolis, has been a writer, editor, college professor, and is an honorary member of Tau chapter, which he served as alumni advisor.

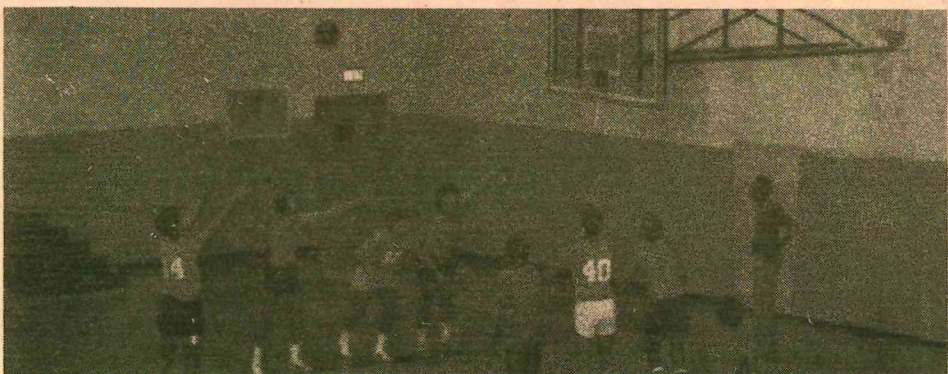

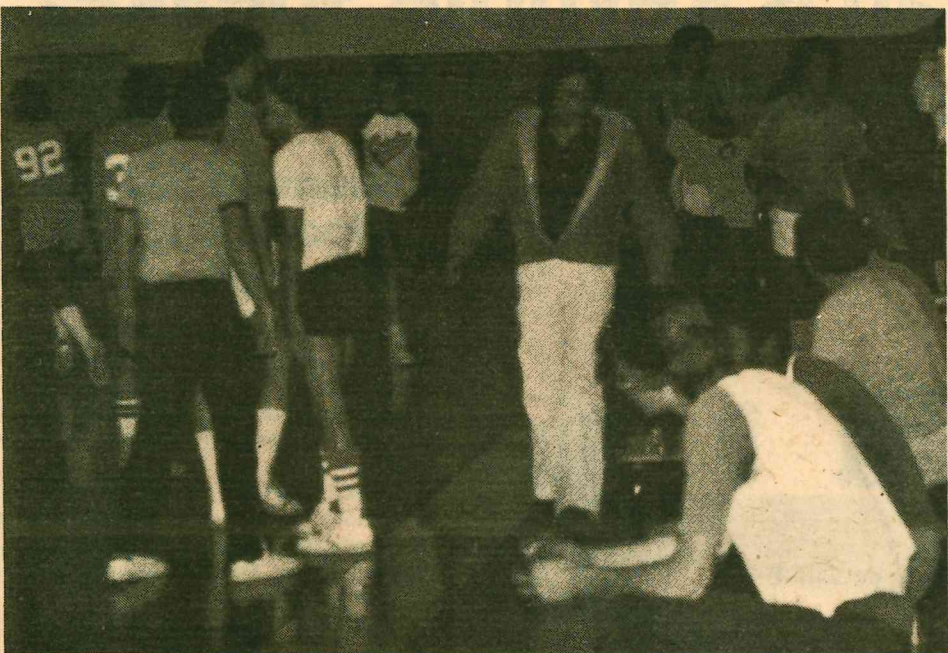

Brothers Conrad Freeman and Jim Cook are working on a baseball tournament which will take place on May 6-7 at Madison's Brick Park.

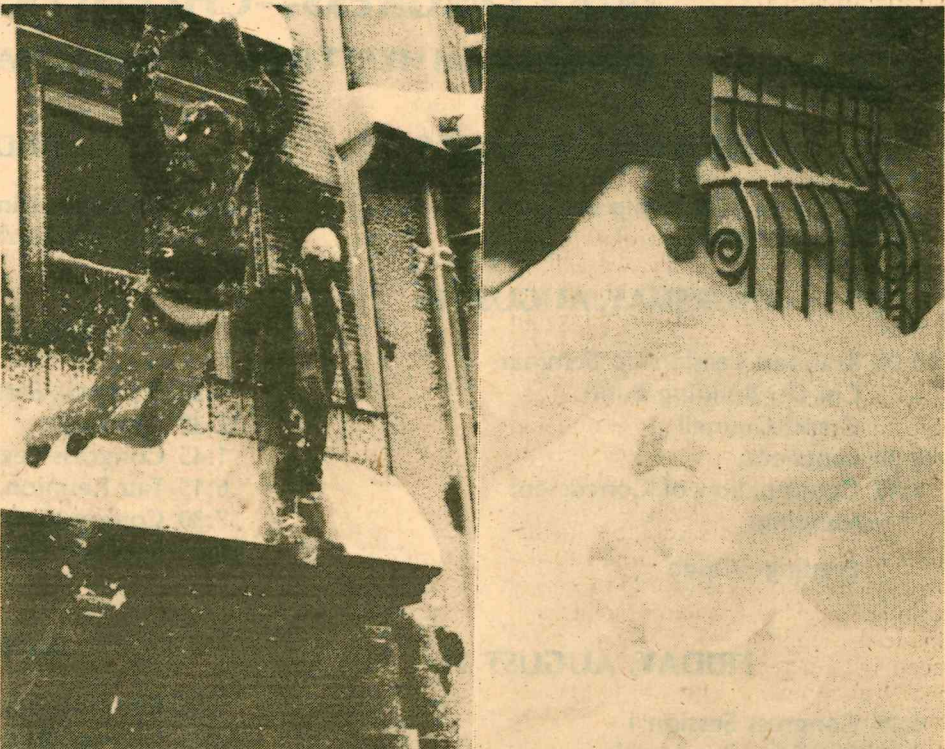
This charity event is being held to "enhance our image and the general fraternity image, and make the relations between the community and the university better" Brother Freeman said.

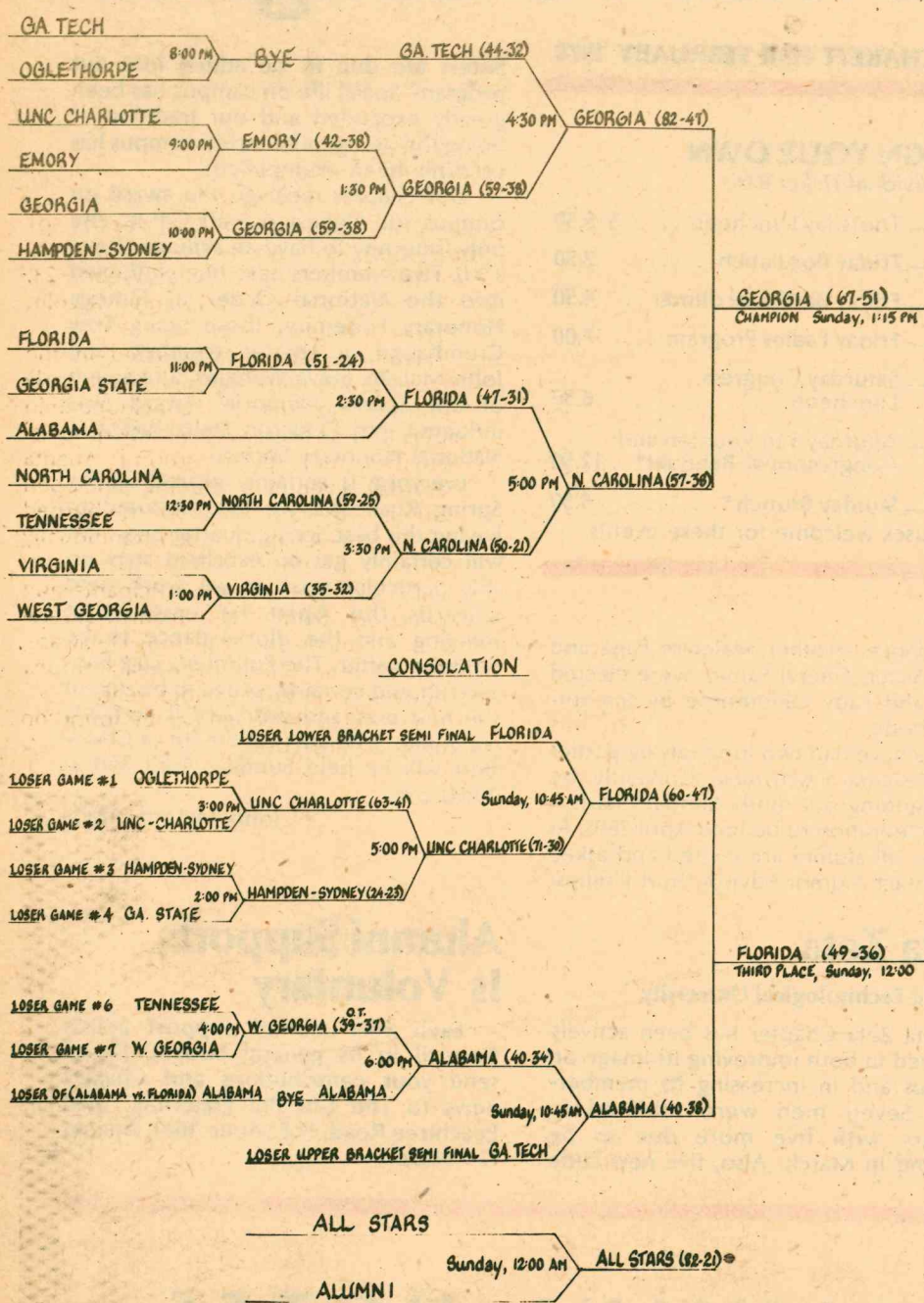

Babcock of Xi Heads Electronic Media For Ithaca's Park Broadcasting Co.

John Babcock, Xi'45, is currently anchoring the broadcasting activities of Ithaca's Park Broadcasting Inc., as that firm expands in print media with the acquisition of daily newspapers in the 10 to 25 thousand circulation bracket.

The president of the Cornell chapter house association was mentioned in a recent Newsweek article which stated Park Broadcasting had reached the FCC's limit of 21 stations—first of the nation's communications giants to do so.

The article featured the company's sole owner, Roy H. Park, whose holdings are probably worth \$80 million, and quotes Babcock on his boss's round-the-clock work habits: "He actually took the afternoon off on the Fourth of July."

Babcock was hired in 1964 to help Park run TV stations in Greenville and Chattanooga, is currently directing all broadcast activity to free other executives in the company for the expansion of Park Newspapers Inc., which was formed in 1972.

According to Business Week the Ithaca headquarters is run as a tight ship, with "only 22" employees. "Park moves fast, and has a nose for profitable properties," the magazine states.

Michigan Rector Has Sermon Newsletter, Investment Report

His bi-monthly investment letters concentrate on the prudent sale of options on investment grade stocks to increase income and minimize the risk of principal.

The initial ten percent of his income from the two mailing services goes to St. Mary's church. Brother Albrecht is using the balance to educate his wife and five children, most of whom are currently in college at Amherst, Princeton, Indiana and Wayne universities.

Stevens Tech Honors William McLean With Honorary Engineering Doctorate

Dr. William H. McLean launched a distinguished career in business and university work with his valedictory address to the class of 1931. His remarks reflected on several elements of a true education giving equal importance to (1) the general association with the learned men of a faculty, (2) knowledge of how to get along with others, and (3) the number of classes attended and books read.

In 1976 Brother McLean, Mu '31, received from Stevens Tech the honorary degree of Doctor of Engineering.

Following his 1931 graduation from Stevens, Dr. McLean earned master's and doctorate from Harvard Business School. His talents were then put to work for the armed forces during World War II in directing research and development for the office of the Quartermaster General.

After the war Dr. McLean pursued a career in the chemical industry in which he rose to president of Merck & Company's chemical division and as a corporate vice president.

He currently holds the joint office of vice president and secretary of the institution and is the designated spokesman for all private higher education in New Jersey with the Board of Higher Education, the State Legislature and the Governor's Office.

Dr. McLean is also a member of many professional societies, corporate boards of directors, state advisory councils, and is a licensed professional engineer serving as a consultant to a number of leading companies.

Income Tax Should be Phased Out

Solon Patterson, Gamma '57, is president of Montag & Caldwell, the largest independent investment counseling firm in the Southeast.

He has recently been elected chairman of the Financial Analysts Federation and was featured in Forbes Magazine for April 1, 1977.

In Solon's viewpoint, American corporations are not expanding because there is not a fair return on new equipment. There is a tendency to use excess cash to increase dividend payout or buy up stock in one's own company or other established firms.

While this may be a smart management decision it is destructive for the economy.

Corporations paid out in income taxes last year about \$60 billion (35% of its total earnings) out of \$375 billion collected. Solon advocates a five-year phaseout of the corporation tax rate by 7 percent per year.

He believes the initial impact would be a sharp rise in business profits followed by an increase in expansion which would create more jobs, more competition, and higher productivity.
