McCall Conducts Pledge Ceremony New Colony at UNC-Wilmington

Sixteen men, most of whom were founders of a local fraternity at the University of North Carolina at Wilmington, pledged the Chi Phi Fraternity thereby becoming a new colony. The pledge ceremony was conducted by Grand Alpha, Darryl McCall, April 25 and was attended by Wilmington area Chi Phi alumni from our Delta (Rutgers), Alpha-Alpha (University of North Carolina) and Mu Delta (Auburn) chapters.

The event was the culmination of discussions and planning which began this past September when Brother Thomas Smith, Gamma '77 (Emory University) proposed that the Wilmington Campus of the university system be investigated for a possible future chapter. As a result, Grand Alpha McCall made contact with Vice Chancellor William M. Malloy who recommended members of a local fraternity who had earned a quality reputation through their programs and campus involvement.

Mutual investigations during the fall were followed by a second meeting attended by Grand Alpha McCall; Grand

Zeta, Steve Schneiderwind; Undergraduate Council Member, Thad Throneburg, and National Director, Ray Donohue. Several visits by members of the local were made to our Alpha-Alpha Chapter in Chapel Hill. The end result of these activities was a unanimous vote from members of the Wilmington group to affiliate with the Chi Phi Fraternity. Grand Council Approval was given leading way to plans for the colonizing ceremony.

The Formal Pledge Ceremony was preceded by a dinner attended by University Officials and Chi Phi area alumni in addition to the 16 UNCW men. A particularly interesting aspect of the preceremony activities was the rejoining or two Rutgers Chi Phi's who were active together in 1949, who had not seen each other since leaving college. Brief post dinner addresses were given by Vice Chancellor Malloy and Grand Alpha McCall. The evening was concluded with the pledge ceremony marking the beginning of efforts to earn a Charter for the new Chi Phi Colony.

Rush Ends Two Year Decline;

Chapter rush results for the recently completed school year reversed a two year decline from the 1973-74 academic year. Two chapters should be singled out as turning in their best results in recent times: Alpha Tau (University of Michigan) and Pi Delta (West Virginia University). Both chapters will be occupying house facilities this fall to levels approaching full capacity with the obvious benefit of greater revenue flow.

Four chapters experienced significant rebounds from the previous year and in two of those cases helped to avert a financial crisis which could have been

caused by older house facilities. The net difference in the four chapters for this year were 48 pledges over the previous year. Chapters included were Gamma (Emory), Mu (Stevens Tech.), Xi (Cornell), and Xi Delta (Florida Institute of Technology).

21 additional chapters turned in good results which reflect consistent performance year by year. Proportionately chapters in the east were leaders in this category and on an overall basis. There was more strength shown by Midwestern groups; however this area (continued on page 2)

(Alpha-continued from page 1) chapter could budget to handle \$30,000 indebtedness under such a schedule. Payout of the existing 12,000 mortgage will leave \$18,000 for improvements. Knowledgeable estimate of needed work come to \$23,000 leaving a void of \$5000 to be closed to the extent possible by alumni contributions. Chapter labor will be used wherever possible and Max Lafferty is donating services to serve as general contractor.

More volunteers are also needed by the alumni affairs committee to serve as area chairmen. Personal and phone contact is planned for geographical areas with concentration on Alpha Chi Phis.

Insurance coverage was found to be pitifully low in relation to replacement cost, adjustments in coverage are being handled by Kent Spain.

It is worth noting that the chapter succeeded in erasing a carry over debt and is operating on a respectable and sound basis. Budgets are already prepared for the school year beginning in September with Kitchin and Social Chairman given their respective amounts.

More than 40 alumni have supported Alpha Home's efforts to upgrade physical conditions at 161 Rugby Road with an average contribution check of \$54.00.

Dr. Richard E. Fuller of Omicron **Leaves Mark in Pacific Northwest**

Dr. Fuller's principal lifelong interests centered on art and his field of study, geology. Upon graduation from Yale, Brother Fuller toured the Orient for an entire year where he began his consuming interest in art. One of the prime results of this influence was his founding of the Seattle Art Museum in 1930 which he continued to direct and promote for forty years. Today, the museum is noted as possessing one of the finest collections of oriental art in this country.

During his years in the Pacific Northwest, he supported and encouraged the development of local artists by buying their works for the museum; encouraging business con-cerns and individuals to follow suit. His support extended to music with a significant contribution to the Seattle Symphony Orchestra. Some of his other philanthropic efforts were the founding of the Seattle Foundation, Pacific Science Foundation and the downtown Seattle YWCA.

In his field of study, Dr. Fuller received his Ph.D. in geology from the University of Washington in 1930. Most noted among his published works was his study on vulcanism in Oregon's Steen Mountains. It is considered a standard in the field.

Dr. Fuller became president of Barkon Tube Lighting Co. in the mid-1930's and director of the Northwest Glass Co. in 1940. He served as chairman of the board of the latter company from 1948-68. He occupied positions of responsibility on many other concerns including director of the Rainier Bank.
In 1972, Brother Fuller was

recognized by friends, business and civic acquaintances at a dinner com-memorating his 75th birthday. More than 900 people were in attendance to hear Dr. Fuller honored for his foresight, selflessness, generosity, taste and quiet appearance as he went about leaving his mark upon the community where he spent most of his life.

Severe Cold Gave Mu Members Winter To Remember

For most of you it may have been a rough year; however, for us at Mu it was a year of crises! To begin with, we returned to school in the fall with only 13 brothers living in the house (about 60% full) and debts up to our ears. Our meal plan only attracted 10 guys, so even our stomachs were in jeopardy. If this weren't enough, in the month of December our heating system broke down and as a result we went with no heat or hot water until March.

Let me try to describe what it is like to go with no heat or hot water in the coldest winter in the history of modern statistics. Portable space heaters brought our average temperature to 38° F; however; with 15 space heaters, our hundred amp circuit breakers blew constantly and our meter twined like it could saw wood. This "cold" did strange things to our digital clocks and calculators, i.e. 82=1.9x10-37 and in an engineering school this was serious business. Furthermore, our wiring is not good enough to handle the load of electric heaters in the rooms, so all through the house there were extension cords from our fuse box running through the halls.

The situation was grave and it was obvious that in order to survive we would have to pull together. Sure, tempers ran short, but through it all we all became a lot closer. To begin with, the effort put into our "Rush" was phenomenal! Seventeen guys were attracted through the "Rush", and despite the fact we attracted more guys than there were of us, we were disappointed when considering the amount of effort put into our rushing program. Of course, as should be well known, "the test is not how many pledges you attract but how many you keep." To accommodate this notion, we changed the spirit (not traditions) of our pledging program. For one, our "Big Brother System" was taken a lot more seriously. The "Big Brother" chosen by his individual pledge, kept closer tabs on him as a friend; making pledging more personal than in past years. We adopted such mottos as "if after pledge activities he is not smiling, you did it wrong," and basically became more truthful and communicating to the pledges as a whole in order to relay the idea that we wanted these guys as friends with the pledging program being necessary only to become a brother of Chi Phi. As a result, we ended up initiating 14 good men in April, the largest class for our chapter in five years. As a result, next term we will return with a full house, plus.

But, how did we survive the cold and other problems? Once again we pulled together. We sacrificed our "house linen service" in order to help pay the bills, and organized "shower runs" as a house to the gym and freshman dorms. With good support of our Alumni Association, we were able to put in a new four zone baseboard heating system, and fix up the house after the heating men practically destroyed it during installation. All in all, I think the secret towards our survival was "togetherness" and I am proud that I was part of it.
