

As news alerts of imminent inclement weather scrolled across every television screen in the metro Atlanta area, Alphas from across

the country began their trek to the Georgia Tech Hotel and Conference Center. However, no threat of ice or snow would cancel the 6th annual Alphas Academy from occurring the weekend of January 6-8, 2017. And, even though the inches upon inches of snowfall never made an appearance, forty-four Alphas did--all ready to embrace the experience the weekend had in store for them.



"So, why am I here?" A guestion posed by the Grand Gamma John Christian, Lambda 1980, who served as this year's Keynote Speaker at the closing banquet Saturday evening. Although Brother Christian offered an answer by providing the men, both Undergraduate and Alumni, in attendance with a rather comical interpretation of his Chi Phi experience, the Alphas had the entire weekend to explore and determine their own answer to that very question.

Grand Alpha Ron Frank, Nu Delta 1983, led the charge throughout the Academy as, right from the beginning, he set lofty expectations for the Alphas. He challenged the men to reflect on the areas in which they excel and where they fall short by means of their own leadership styles as well as the state of their Chapters. To further encourage their growth, Brother Frank guided participants through conversations ranging from organizational identity and recruitment, to alcohol and hazing, to well being and leadership with no topic being off limits.

The program was complimented by guest speakers from the Educational Trust who offered insight into ways in which Chapter Excellence Funds, the Men of 1824 program, and scholarships from the Educational Trust could benefit not only personal growth but also Chapter health. Trustees along with fellow Alumni from Chi Phi Chapters across the country also attended, offering their own words of wisdom to the young leaders through various sessions, meals, and the Alumni Panel. It was during one of these gatherings that an Alpha realized, "my problems and challenges are not unique," while another participant noted, "the connections made here allow for you to understand your Chapter isn't alone." The men gained a solid understanding that indeed, "the hand of Brotherhood is always extended"-beyond graduation, beyond Chapter designation—and that support is never more than a phone call or a text message away.

Although the icy weather confined attendees to the hotel for the duration of the program, the Undergraduates were

privy to a variety of learning methods: small and large group sessions, Alumni and Grand Council Panels, one-on-one meetings with facilitators/peers, and a guest speaker. Returning this year once again was Cori Wallace, Director of Sorority Relations for OmegaFi, who offered her insight on "What it Means to be a Fraternity Man." This interactive presentation challenged the men to truly see their Chapters for what they were and encouraged them to start defining their legacy now. The multiple opportunities to engage and network with peers, Alumni, Trustees, Grand Council, and National Office Staff was not lost on the participants, as one leader reflected that "Alphas Academy was one of my favorite weekends and one of the most rewarding experiences during my time in Chi Phi."

However, as noted above, Brother Frank was not alone in his endeavor to Build Better Men throughout the weekend. He was supported by fellow Chi Phi Alumni and former Undergraduate Alphas serving as small group facilitators. In fact, this was the first year of the program in which the facilitation team was comprised entirely of Chi Phi Brothers. Those in attendance donating their time and lending their expertise were Grand Alpha-Elect Bob Walker, lota Delta 1970; Past Grand Alpha Jim Soderquist, Alpha 1967; Sean Murphy, Lambda Theta 2008; David Ross, lota Zeta 1996; Carl Michel, Lambda Zeta 1999; David Ebner, Delta Zeta 2008; Nicholas Medina, Lambda Zeta 2008; Grand Iota Alec Day, Towson Colony 2018; Josh Matt, Xi Theta 2018; Wyatt Janning, Gamma Zeta 2017; and Jonathan Fall, Delta Pi 2016.

During the closing banquet Saturday evening, Brother Christian eloquently articulated, "as Brothers in a Fraternity founded upon the ideals of Truth, Honor, and Personal Integrity, we have an obligation to ourselves-to each other-to strive for excellence." And, there is no question that all in attendance at the 6th annual Alphas Academy understood the value and importance of just that.

2017 REGIONAL LEADERSHIP ALLIANCES

The 2017 Regional Leadership Alliances offered both Undergraduates and Alumni a completely revitalized program—with a Keynote speaker specializing in sexual assault awareness, fewer and more impactful general sessions, along with innovative curriculum found in thirty-two breakout sessions. Based on evaluations from previous years as well as data compiled from a survey sent to all Undergraduates in the fall of 2016, we redesigned this day and a half long program to offer students more control over their experience. Although many challenges and obstacles facing Chapters across the

country are not unique, their approaches to solving those problems often are. Therefore, this year's program allowed for participants, regardless of whether they held a leadership position, to attend sessions that they found meaningful, engaging, and pertinent to their Chapter's needs.

The program kicked off on Saturday morning with our Keynote Speaker from One Student, who offered attendees guidance on what makes a healthy sexual relationship, an understanding of the term "consent," as well as bystander intervention techniques in regards to sexual assault awareness.



From here the men dispersed to their choice of breakout sessions. Facilitated by Chi Phi Alumni and Greek Life professionals, topics included specific Officer and Chairmen tracks, resume writing and interview skills training, Alumni engagement, "Motivating the Middle," how to take your Chapter from "Good to Great," and even more specific topics including Robert's Rules of Order and an interactive mock Court of the Chapter.

During lunch, attendees heard the State of the Fraternity Address presented by a member of the Grand Council or a Regional Alumni Counselor. Here, the Undergraduates and Alumni present gained an understanding of those areas in which the Fraternity is excelling and those which still need fine-tuning. With full stomachs and a plan in place to ensure maximum learning for all Brothers, participants spent the majority of the afternoon engrossed in the final round of small group sessions. Day One of RLA concluded with a presentation, led by either a member of Grand Council or a Key Alumnus, that served as a reminder of the importance and significance the Core Values have on the history and Ritual of the Fraternity.

Because there is no better way to begin a Sunday morning than with a Risk Management presentation, Day Two of the program found participants engaged in an interactive session during which they discussed Chi Phi's Personal Safety Policy and analyzed case studies. The men were challenged to identify the policy violations within each incident and discuss ways to hold members accountable. Brothers quickly realized that the longevity and health of their Chapters revolved around proactive measures, strong accountability, and educated members.

With so much information accessible and acquired throughout the weekend, it was only natural to conclude Sunday morning with time for each Chapter to reconvene and devise their next steps. Guided by a facilitator, the men were tasked with outlining a strategic plan, establishing goals for the remainder of year, and identifying solutions to problem areas. Equipped with the tools to succeed and contagious enthusiasm, there is no doubt that participants of the 2017 Regional Leadership Alliances are destined to make a positive impact on their Chapters and future of the Chi Phi Fraternity. One of our goals is to increase the endowment of the Trust so we can provide more funding to the educational programs put on in conjunction with the Fraternity. The educational programs are informative. I was an Alpha at the Eta Chapter and it would have benefitted me greatly to attend an Alphas Academy back then. Such an opportunity wasn't available at the time, but it's an opportunity that's there now. It's a very, very good program run by both the Fraternity and the Trust.

What do you wish people knew about Chi Phi?


I think today fraternities have garnered a bit of a bad reputation but they do a lot of good. There's a place for fraternities on the college campus. They present an opportunity to meet other students and become lifelong friends. That's what I try to tell people, and that's why I'm giving back to Chi Phi. Chi Phi was good to me in many, many respects.

What do you like the most about being involved with Chi Phi as a volunteer?

The Trust performs a really important benefit for the Fraternity because of scholarships we provide and the funding for academic programs. We do a lot of good, and I'm proud to be part of the good we do. The other part is that I've met quite a few exceptional people, both members of the Trust and Alumni of the Fraternity, who continue to give back. Those are people I would not have met if I had not become a Trustee. I've met a lot of really interesting people and made a lot of good friends because I've been involved.

What's your favorite Chi Phi memory as an Alumnus?

I have two favorite memories since I've graduated from college. The first is seeing the new Eta house built. It's a fabulous house and I'm very proud of it. The second is my service to the Trust. I've enjoyed the three years I've been a Trustee and I've really enjoyed all of the great benefits the Trust provides.



The 7th Annual Watts Gunn Tournament will be held Thursday, June 22, 2017, at The Foundry Golf Club in Powhatan, Virginia. This course winds through the wetlands along Fine Creek, where golfers will encounter a wide variety of holes. The Foundry, a private, members only club, strives to provide the best possible golf experience in Virginia. By being a true golf club, membership is limited to 250 people.

The Tournament raises funds to support Chi Phi leadership development programs while honoring Watts Gunn, Omega 1928, known as "The Southern Hurricane." Gunn made golfing history in 1925 in the U.S. Amateur, setting the world record for international championship golf by winning 15 straight holes in the first round of the 36-hole match. In that tournament, he went against friend and rival Bobby Jones, marking the only time two players from the same city have ever met for the U.S. Amateur crown. In 1926 and 1928, he went on to play on the Walker Cup teams with Bobby Jones, defeating the British team both years. He played many benefit tournaments, including several exhibitions with Bobby Jones in 1927 and 1928. He won the Georgia Amateur title in 1927 and 1928, and he has been inducted into the Georgia Tech Athletic Hall of Fame, Georgia Sports Hall of Fame, Georgia Golf Hall of Fame, and Southern Golf Association Hall of Fame. There are only 32 player positions available in the 2017 Watts Gunn Tournament, available on a first come first serve basis. Alumni and sponsors are encouraged

to register early to ensure availability.

Tucked deep within the archives at the William M. Byrd National Headquarters in Suwanee, Georgia, is a collection of old Chapter registers and minute books. They date back to the mid-nineteenth century and are written in what Grand Epsilon Matt Scheller, Psi 2007, describes as "beautiful, flamboyant calligraphy," which captures the essence and foundation of Chi Phi Fraternity; our history.

The values and standards we hold today build upon the influence of our past. As Chi Phis, we represent what our founders created – an organization celebrating tradition. The archives within the Greek Life Museum are one way we celebrate that tradition. The treasures within these archives exist in boxes upon boxes of incredible documents recording the earliest moments of Chi Phi's existence.

As the oldest social Fraternity, Chi Phi is in a unique position to preserve the archives, which includes artifacts from a longer time frame than any other Fraternity. Phases I and II consisted of creating the Greek Life Museum and the collection of artifacts from Chi Phi and other Greek organizations across the country. The goal of Phase III of this project, which is presently underway, is to catalogue and digitize the considerable number of items held within the Chi Phi archives.

The archives contain nearly 2 million individual documents. This includes 144 boxes sorted by Chapter, old editions of *The Chakett*, bound materials such as minute books and programs from past Congresses, photos, relics, books in the museum, and much more! Starting with boxes of items from each Chapter, which make up the bulk of the materials in the archives, documents will be organized and scanned into digital files. Physical versions of the digitized items and documents will be preserved within the archive space for long term storage in acid free housing to be easily accessed by visitors to the Greek Life Museum.

Chi Phi Brothers will have access to the digitized documents through an online database which will be hosted on the Museum's webpage. Artifacts will be catalogued by keyword for easy searching and once each Chapter's box is digitized, Brothers from that Chapter will be able to gain access to the database from anywhere in the world. The Greek Life Museum

is a beautiful space, but only a small number of Brothers will have the opportunity to visit. Upon this project's completion, Brothers from Georgia to California to China will have the same opportunity to get inside the heads and hearts of Chi Phis from a century ago.

The safeguarding aspect of this project cannot be ignored. In addition to broadening Chi Phi's reach on a global level, if anything happened to the physical archive itself, digitized copies of artifacts are preserved for eternity. Nothing can replace the moment a Brother first sees documents from 20,

50, or 150 years ago, and no price is too high to save these important pieces of Chi Phi's history.

A LASTING LEGACY of brotherhood

The relationships that Richard Crannell, Theta Delta 1976, has made since becoming a Chi Phi inspired him to leave a lasting legacy through a \$250,000 bequest to the Chi Phi Educational Trust.



When Richard arrived in Gainesville in 1972, he had no idea what awaited him. He entered the University of Florida during a time of unrest; the Vietnam War was ending, but protests were still rampant on campus. He found a safe haven in the Brotherhood of Chi Phi.

"I had friends from high school and my hometown who were Chi Phi Brothers," he recalled, "and they invited me to learn more about the Fraternity." Richard didn't have the same history with any other fraternities on campus, so he finally listened to his friends in Chi Phi urging him to join. Needless to say, he made the right decision.

Chi Phi's emphasis on personal relationships stood out to Richard: "I've been in two Brotherhoods in my life. Chi Phi was the first. The second is a Crew here in South Florida. My skin

could have been pink. I could have been speaking Swahili, and they wouldn't have cared. The day I walked in as a member, they all called me Brother, and they treated me as one. That's what Chi Phi did in college and continues to do today."

Richard's planned gift will support Theta Delta's Chapter Excellence Fund through the Chi Phi Educational Trust. His hope is to make the Chapter more competitive, offering more scholarships and educational funding to members than other fraternities at UF. "I want to give them an opportunity to better their education, better themselves, better their future families and become great citizens," he said of his gift which will continue to help Theta Delta Brothers for many years to come. "I wanted my estate to go where it would have the greatest

impact," Richard told us, remembering how he and his wife, also a UF graduate, felt that making funds available for young men who want to better their lives was the couple's chance to leave a legacy. Richard hasn't always been active in Chi Phi and he does not consider himself the type to hold an office. His role, Richard says, is more like support staff to his Brothers. He prides himself on leading with actions instead of words. His gift to Chi Phi captures that spirit.

Though they also support several other charities, Richard and his wife knew Chi Phi was a way to directly aid young men in achieving their goals and aspirations. The friendships Richard has made, along with the experiences during those four years and beyond, have enriched his life to this day. "I have true, lifelong friends in Chi Phi. They're the ones who would do anything for me, no matter what I asked." "We treat each other as Brothers. It's not just a word. It's a mentality in how you treat each other, how you feel about each other, how you care about each other."

A JOURNEY: FROM COLONY TO CHAPTER, A GAMMA ZETA SPOTLIGHT

During the 151st Congress in Columbus, Ohio, our Gamma Zeta Colony at the University of North Carolina at Wilmington had the pleasure of presenting their Petition to Charter. Former Alpha Wyatt Janning, Gamma Zeta 2017, spoke with passion to the Grand Council about their struggles, the work they put into the community and the campus, and what the honor would be like if their Petition was approved. Their effort was rewarded with unanimous approval. On October 22, the Gamma Zeta Colony became a Colony no more. The hard work that the men of Gamma Zeta put into the true bonds of Brotherhood culminated into one thing; they built each other up to be better men.

Associate Director of Growth Danny Zayas (DZ) had the chance talk with former Alpha, Wyatt Janning (WJ), to ask him about Gamma Zeta's experience of going from Colony to Chapter.

DZ: What was one of the most difficult tasks in getting everything ready for petitioning? WJ: The most difficult part of the process of petitioning to charter had to be the conclusion of the Petition itself. The Petition itself is essentially an investment opportunity that we had to pitch to the Grand Council. It encompasses "why." The entire 120-page document screamed, "give us a shot, and I promise it will be a decision you will never regret." Forming it into a business pitch, documenting every step along the way was challenging because we knew this was our one shot to make history.

DZ: What would you say is the most rewarding part of being a Founding Father?

WJ: The most rewarding part is sharing the connection with the original Founders of Gamma Zeta from 1977 and sharing an equally important connection to the kids who go from unknown classmate to Brother, especially in the first New Member Class. To see guys start in the Fraternity as Brothers and not knowing if they really care, then see them filling a position that means everything like lota [Recruitment] or Theta [New Member Education] ... that is rewarding.

DZ: If you could go back in time and do it all over again, would you do it? Why or Why Not?

WJ: If I could go back I would let the culture change happen as the different New Member classes assimilate into the Brotherhood. It is extremely important that there is not a divide between the Founders and the class two or three semesters later. We had many times where there was a push for a change in culture and the Founding class held our ground and convinced key players in the Colony to stick with us. Luckily for us, we have always had a strong Executive Council to clearly define where we are going, an Alumni base that we can call if we have problems, and a Brotherhood that is open to change and ideas that could create opportunity and relationships. DZ: You had the opportunity to speak in front of the Grand Council on behalf of Gamma Zeta after submitting your Petition to Charter; what was that like for you? What was on your mind? How did you feel before and after?

WJ: It was a very laid-back and extremely open environment. I was welcomed with smiles... and then I just let my heart speak. I had donated probably thirty hours a week since the fall of 2015 to the Fraternity ... the Fraternity doubled in size, faired well in Accreditation, and most importantly grew in spirit. I poured my soul into the Petition. It took hundreds of hours to draft. Had there been anything wrong with the Petition I was there to defend it. They voted immediately in front of me and passed it unanimously. It was the single greatest achievement and moment of joy I had felt in my life.

DZ: What advice would you give to current Colonies of Chi Phi that have just started and will eventually submit their Petition to Charter?

WJ: The Petition needs to be completed in five to six weeks. Assign different parts to the appropriate Executive Council or Colony member and lead them through a fourweek program for the summary, strengths, weaknesses, etc., of the Colony that must be included. The fifth week is for filling in blanks and editing. By week six, get it in front of the Grand Council. The reason for the specific and seemingly unrealistic timetable is due to the craziness of college life. If writing the Petition drags on for over two months, it will be a pain in the butt for whoever is leading it. Most importantly: OWN THAT THANG! This is your life's work in the Fraternity. Do NOT be the Founding class that could not fulfill its purpose. If the fellas at UNCW can get it done (you should see the motley crüe formerly called "exec"), you can too.



Theta Chapter Brothers share new haircuts

Theta Chapter at Rensselaer Polytechnic Institute

On April 8, the Theta Chapter hosted their first St. Baldrick's Foundation philanthropy event in collaboration with the Theta Chi Fraternity. St. Baldrick's Foundation is the largest private funder of childhood cancer research grants – since 2005 they have awarded more than \$200 million in grants for cancer research.

The event took place on RPI's Accepted Students Day celebration to both encourage participation from the incoming Class of 2021 and promote Greek life at Rensselaer among these students. This event also served to unify the Greek community with twelve fraternities and sororities participating and more than fifty students shaving their heads. Their combined efforts raised in excess of \$21,000 for childhood cancer research.

Theta hosted this event in honor of a twelve-year-old survivor of Desmoplastic small round cell sarcoma – a very rare and aggressive cancer which has a five-year survival rate of only 15%. The Brothers of the Theta Chapter stood in support of not only this young survivor, but all those touched by cancer when seventeen members shaved their heads, raising over \$5,200 in the process.

Mu Chapter at Stevens Institute of Technology

Jonathan DiGiacomo, Mu 2016, and Angelo Popper of the Sigma Phi Epsilon Fraternity, both from the Peer Educator Program at Stevens, hosted a workshop challenging gender norms and stereotypes surrounding what it means to be a man. Throughout the workshop the two fraternities worked together to dispel many of the misconceptions that plague fraternity life, such as stunted emotions and unnecessary aggression. Through the breakout sessions, the Brothers of Chi Phi and Sigma Phi Epsilon concluded that identity is what you make for yourself and that ending these harmful stereotypes begins with us.

GPS tracking technology, which helps families whose autistic children may wander and thus provides these children with a safer way to play and explore, and is also used to provide community-based training and other resources for these families.

The Brothers of Alpha-Tau especially proudly boast consistently being one of the highest-earning chapters on campus since their involvement with the tournament began. Alpha-Tau raised \$5,825 this year, bringing their total to nearly \$20,000 raised for the Autism Alliance in the last three years alone.

Alpha-Chi Chapter at Ohio Wesleyan University

This year Alpha-Chi took home the Ohio Wesleyan Greek Awards for Outstanding Alumni Relations, Best Chapter Program of the Year (Community Harvest Festival), The Fred Meyers & Carolyn Tarbell Award (Most Outstanding Greek Athlete, Brian Jordan, Alpha-Chi 2018), and the Chapter Excellence Award in Gold Category.

In April, the Alpha-Chi Chapter hosted a tricycle race with several relay-style events that other student and Greek organizations on campus competed in. The event took place on the residential side of the campus and was open to the public. The Chapter raised several hundred dollars for RAINN during the race.

Alpha Delta Chapter at Pennsylvania State University

Alpha Delta's philanthropy efforts got off to a strong start in the fall by partnering with the sisters of the Alpha Chi Omega Fraternity to host a volleyball tournament and BBQ at the Alpha Delta Chapter house, raising a little over \$1,500. Alpha Delta also hosted a car smash with the Phi Sigma Rho Sorority. This event rasied more than \$1,400. Money from both the volleyball tournament and the car smash were donated to the Boys and Girls Club of America.

Spring philanthropy efforts began with Penn State's THON weekend. For the second year in a row, Alpha Delta partnered with the Orchesis Dance Company. Fundraisers for THON included two canning weekends in the fall, merchandise sales, and other fundraising campaigns with Alumni and families. This year, Alpha Delta raised over \$19,000 for THON!

They continued spring philanthropy after THON with three additional events. The first was a raffle ticket sale, partnered with Phi Sigma Rho. With a grand prize of \$300, over 600 tickets were sold and a total of over \$3,100 was raised. They also hosted a wing eating contest with the Sigma Kappa Sorority which raised about \$600. Both these events benefited the BGCA.

Their last fundraising effort benefited the American Cancer Society through Relay for Life. In addition to fundraising through Alumni, friends, and families, Alpha Delta held another car smash. The one was held on Penn State's campus, something which the fraternities at Penn State have not done in many years. It required weeks of planning and working with the administration, and the Chapter raised over \$1,000 for a great cause.

Omega Zeta Chapter at University of North Florida





Stephen Bricker, Alpha-Chi 1969, advocate for rights of others, died October 11, 2016

A passion for justice and the rights of other people moved Stephen Winston Bricker, Alpha-Chi 1969. "He said it came from his father," who also was a lawyer, according to his wife, Janet.

Brother Bricker attended Ohio Wesleyan University, to which he applied sight unseen while his family was living in Tokyo. He majored in English and joined the Alpha-Chi Chapter of the Chi Phi Fraternity in the spring of 1966. After graduation he worked as a reporter for a newspaper in Annapolis, Maryland, and as a humane officer for the Washington, D.C., Humane Society, investigating reports of cruelty to animals and filing complaints before deciding to follow his father to law school at the University of Virginia.

While in law school, Stephen worked with the American Civil Liberties Union of Virginia to begin a Post-Conviction Civil Liberties Assistance Program to represent indigent prison inmates. Brother Bricker and his colleagues helped prisoners who felt they were wrongfully convicted and had no money to pursue their defense.

In 1974, the ACLU hired Brother Bricker to head its new Children's Rights Project of Virginia, the first initiative of its kind in the nation. At the time, about 12,000 children languished in foster care in the state. Two-thirds of them could not be adopted and had no hope of being reunited with their parents. The project enabled more than 8,000 of them to leave legal limbo in order to be placed for adoption.

From 1975 to 1976, Stephen served on the Juvenile Justice Code Revision Committee of the Virginia Advisory Legislative In 1978, Stephen defended and won judgment for a prisoner who lost the use of his legs because he developed maggot-The 25th anniversary edition of Virginia Lawyers Weekly compiled the top 25 jury awards handed down in the state from Mr. Bricker, who was a partner in the law firm of BrickerAnderson PC, was a former president and governor of the Virginia Trial In addition to his wife, Brother Bricker is survived by a son, Louis Bricker, and a daughter, Melina Bricker, both of Richmond,

infested bed sores. "The prisoner's son became a lawyer because of Steve," recalled his wife. Two years later, he worked on a case was meticulous in hunting down every little piece of information.
