

Dues Feel Inflation's Pressure

The Congress sessions were serious and well conducted by Alpha of Congress, Barlow Ware, Xi '47, the outgoing Grand Epsilon.

Legislation that was passed included: An increase in the initiation fee of \$5, effective September 1, 1975. An increase in the Pledge fee of \$5 effective for each chapter following their next initiation.

A revision of the chapter travel rebate whereby the base on which the rebate is calculated is increased to \$200 from \$150.

A requirement that the chapter take proper steps to adequately file and preserve initiation records, chapter minutes, financial records and other important papers.

The matter of increasing the voluntary alumni dues was debated. The delegates finally turned the matter over to the Council for an ultimate decision.

With the inflationary pressure upon the Council's budget in mind, the delegates considered switching to a biennial Congress, but the non-monetary advantages seemed to offset the budgeting consideration. The present program of providing financial assistance for the annual Regional Conferences was approved despite the contention by some delegates that the program could be sustained without financial support from the Council.

A motion to publish the Chakett three times a year instead of four was overwhelmingly defeated.

Alumni and chapters in the Columbus, Ohio and Orlando, Florida area expressed a desire to host the 1976 Congress. The Council was instructed to make a cost study of the expenses involved at both sites and then make a determination.

Darryl McCall Chi Phi's 49th Grand Alpha

Chi Phi's 49th Grand Alpha, Darryl McCall, Theta Delta '50, Gamma '52, Psi Delta '70, is Professor of English at the University of North Carolina, Charlotte. Other educators have held this high honor including Dr. Edwin E. Sparks, for whom the Sparks Memorial Medal is named, O.B. Williams, Professor of Bacteriology, University of Texas, and Carl J. Gladfelter, former Professor of Marketing.

Brother McCall was born in Miami, in 1929. He grew up in Coral Gables and attended Ponce de Leon High School before matriculating at the University of Florida. He was initiated in 1948 by Theta Delta. Later while doing graduate work at Emory University in Atlanta he affiliated with Gamma. He did further graduate work at Balliol College, Oxford, England.

In addition to his teaching duties at the University of North Carolina, Charlotte, he is Chairman of the University Executive Committee and is a past president of UNCC College Faculty (1973-74). Always active in his field, he has served as President of the North Carolina-

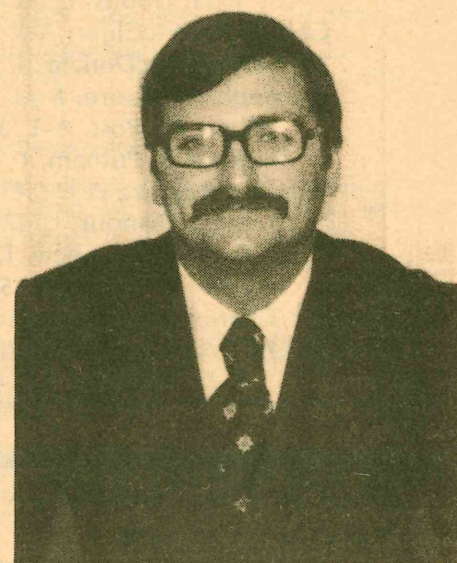

Rogan, New Grand Delta, From Wisconsin

The new Grand Delta is a 1965 graduate of the University of Wisconsin. As an active Edward served the Kappa Chapter as Alpha and Beta. He represented the Kappa Chapter at the Indianapolis Congress in 1964. At Indianapolis, Ed served as chairman of the Constitution Committee. That Congress, upon the Committee's recommendations, made modifications and modernized sections of the Constitution that enabled Chi Phi to withstand subsequent pressures exerted by the counter-culture groups on various campuses in their attacks on fraternities.

Reflecting on that Congress, Ed feels that "while we made changes in 1964, we completely missed seeing the turmoil and currents of change that would emerge on campus in the late sixties. Through the herculean efforts of our leadership—nationally in the person of Carl Gladfelter, and locally through alumni willing and capable to work for Chi Phi—we withstood our greatest challenge since the war years and won. Chi Phi is alive, vibrant, and well. Our new members are joining our Brotherhood because they want to. At the most recent Congress not once was the old, trite battlecry of the sixties sounded, "what is Chi Phi doing for me?" Based on the momentum I see this fall of 1975 I predict Chi Phi will reach new heights of collective strength by the end of this decade.

Edward's current projects include breaking in a new regional counselor and co-chairing the Wisconsin 150th Anniversary celebration.

Edward married another Wisconsin graduate, Toni, and they have a daughter, Hilary, age seventeen months. They live on a small lake outside of Libertyville, Illinois, where fishing, swimming and hiking are their leisure time activities. Ed is a member of the local elementary school board and to the chagrin of his friends in real estate and construction is an open space activist in

Iota Observes Sesqui With Dinner-Dance

Iota celebrated the 150th anniversary of Chi Phi with a large gathering of their members and wives in Columbus the week-end of September 20-21. The big affair was highlighted by a dinner-dance at the Arlington Arms Motel following the Penn State game.

The local chapter under the name of Iota was one of the first on the OSU campus, being chartered in 1883. Prior to the move to 2000 Indianola Avenue in 1912 when that house was purchased for \$12,000 the chapter made its home far in town at Highland Avenue. A large addition was added and dedicated the day of the Michigan-OSU game in 1926.

A metal plaque commemorating the 1824 founding was presented Gene Iacovetta, chapter president, by Rae Donohue, Assistant National Director of the fraternity from Atlanta. It will be affixed to the front of the house.

Charles Brooks '46, Mansfield auto dealer, acted as master of ceremonies at the dinner event and started off the program with the introduction of William Jeckell '34, Cincinnati, National President of Chi Phi, 1969-73. Jeckell spoke on "The Thrifty Thirties" and recalled many memories of that era including that October 7, 1933 date when Henricks was SRO as the 10 cent 3.2 beer made its debut on the first day of prohibition repeal. He recalled later the auction in 1934 at the same campus hangout when the 10 cent coke and 10 cent hot dog and the depression finally caught up with Herb. Other recollections brought out the lowest attendance in stadium history in 1932, 113, 718 at 5 home games; the tossing of the World's Fastest Human, the late George Simpson, into the Olentangy River in the spring of 1931 by fraternity pledges; and the 25 cent ride downtown with 5 students in a Hills Cab.

Brooks spoke on "The Fighting Forties" when Chi Phi, like most other OSU fraternities, closed their doors as members went off to war. A special recording of excerpts from the music of 10 Big Name Bands of that period drew sighs from the audience. Three other fraternity members spoke on the next three decades: Dick Sly '59, Lorain, on "The Fabulous 50's"; Dick Baker '67, Worthington, "The Sizzling 60's"; and Paul Streibig '75, Columbus; "The Soaring 70's". Sly recalled that the first color TV at a campus fraternity in the 50's attracted big afternoon audiences to the Castle on The Hill. He also told of the disqualification of the chapter in the judging of the house's Homecoming display featuring the cow with the "udder defeat". Baker recalled the member in 1966 with the first beard on campus which attracted University displeasure.

Charles Drinkle '13, Lancaster attorney, was awarded a trophy as the oldest member in attendance, and Maurice Gerhard '31, Kalamazoo, Michigan as the one coming from the greatest distance. A 15 minute sound slide presentation, narrated by Walter Cronkite, A Chi Phi Texas University grad of 1937, presented the fraternity history of 150 years. The weekend concluded with a special ritual ceremony at the chapter house Sunday morning. Committee members planning the event included co-chairmen Lee Wears '35 and John Moore '35; Dan Dozer '65; Jim Zikas '47; and Mike Haist '58 all of Columbus.

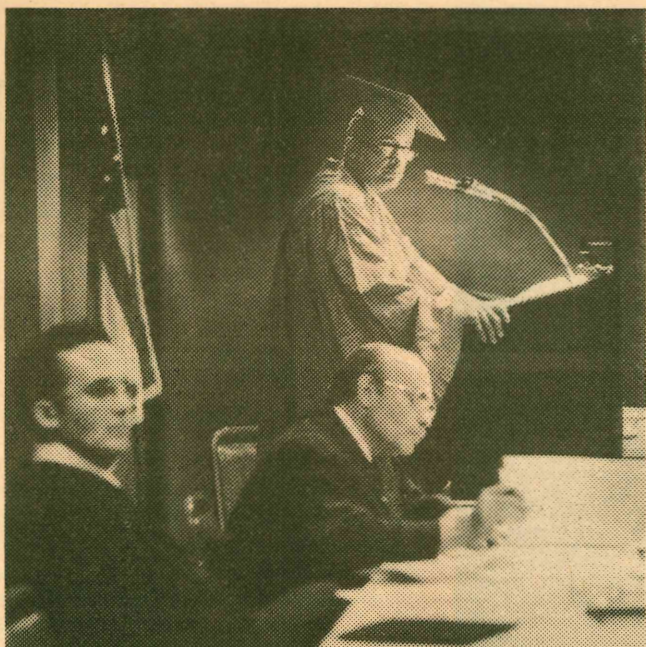

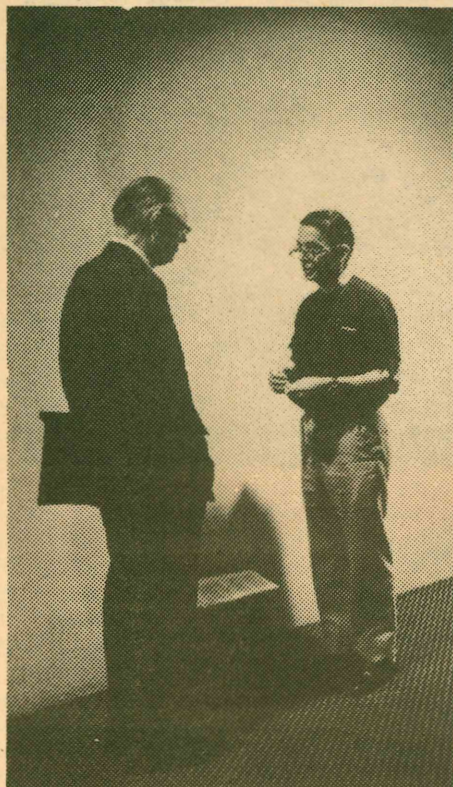

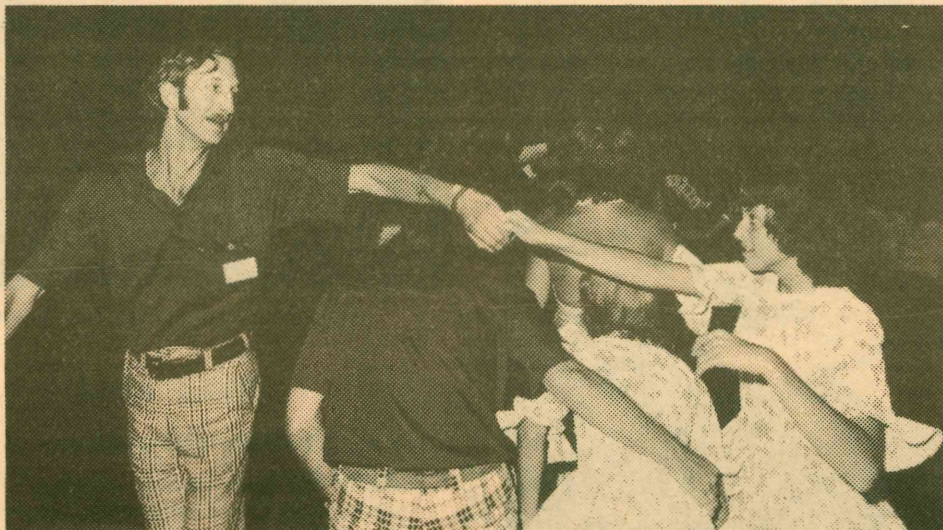

Sigma '28, 1961-1963; Undergraduate Member Council, Frank Kovacs, Iota '72, 1971-1972.

Largest alumni delegation, some 15-20 plus wives was that of Theta Delta which was celebrating the installation of its first alumnus as Grand Alpha. Dr. Darryl McCall was initiated at Theta Delta in 1948, and several alumni who were at Gainesville, Florida at the same time were among the group attending.

Alumni wives have to be long-suffering to put up with a fraternity convention, but the special ladies program helped immeasurably.

The actives, with dress and talk now more conservative than a few years ago, are also more ritual-oriented, and the Sesquicentennial has stimulated interest in the past. Nearby chapter, Alpha-Alpha at the University of North Carolina, Phi Delta at University of Tennessee, and Psi Delta at UNC Charlotte, conducted the model initiation, the libation ceremony and the candlelight ceremony respectively in an effective and dignified manner.

Student leadership was evident in abundance, with committee meetings well attended, each with a regional counselor or National Officer to assist. While there were no major pieces of legislation to be decided, and sessions were generally short, a committee recommendation that Congress be held in alternate years as a money-saving measure was voted down so better continuity could be maintained. Alumni will recall that the active chapter delegates meeting in Congress control the fraternity, under our Constitution.

FUN, FROLIC, INSPIRATION

As would be expected of Chi Phis—both alumni and actives—the evening social events were exuberantly at-

tended, and smaller parties continued on into each night, despite the fact that each morning session started at 8:30 or 9:00 A.M. with good attendance.

Wanderers in search of beverages and conversation found open doors and hospitality in abundance.

The concluding note on a higher level was the inspirational talk by the Rev. Jack Pace, Theta Delta '40, former Grand Beta and now Ritualistic Counselor, which has become a Sunday morning feature of Congress.

Yes, 150 years ago, and today, Chi Phi serves the needs of young men, and alumni may be proud that their own college fraternity interest is being perpetuated today by actives from our 45 chapters, even though many did not exist 25 years ago.

PROBLEMS STILL

Problem-solving is still a major part of fraternity existence. Many of today's college generation attend commuter universities—non-residential schools, but Chi Phi is firmly established at several of them, though problems in chapter operation exist.

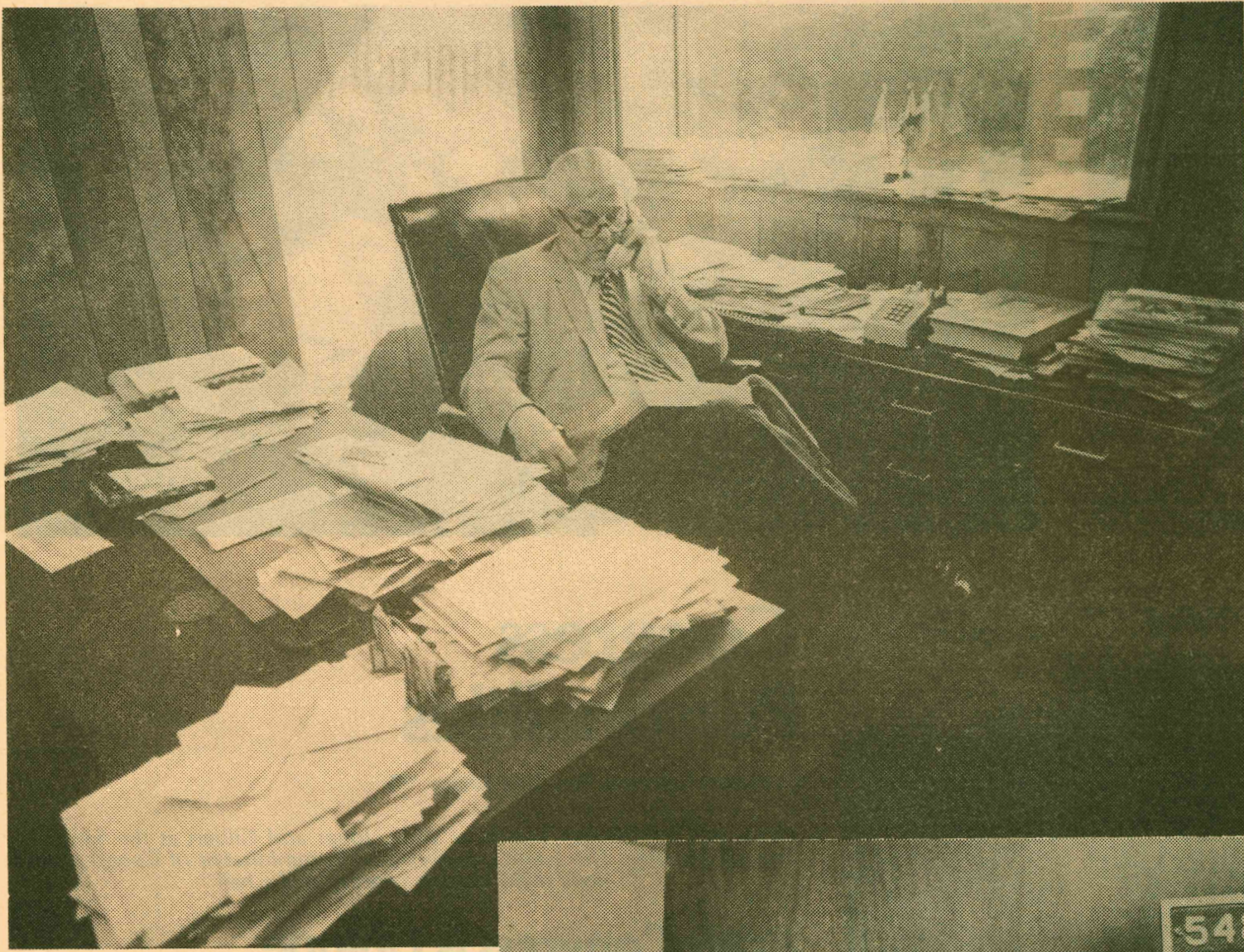
In addition, a great many young men start their college career in a Community or Junior college, transferring later to the four-year school. Chi Phi is investigating how such men can be given fraternity opportunities in their first two years with a pilot Chakett Club in one community college, which has already provided two chapters in four-year schools with transfer members.

In common with all of America, the inflationary spiral creates the most dangerous of today's fraternity problems.

Still, 150 years of survival and service to young men is good evidence that Chi Phi will solve today's problems; as it solved those of the past.



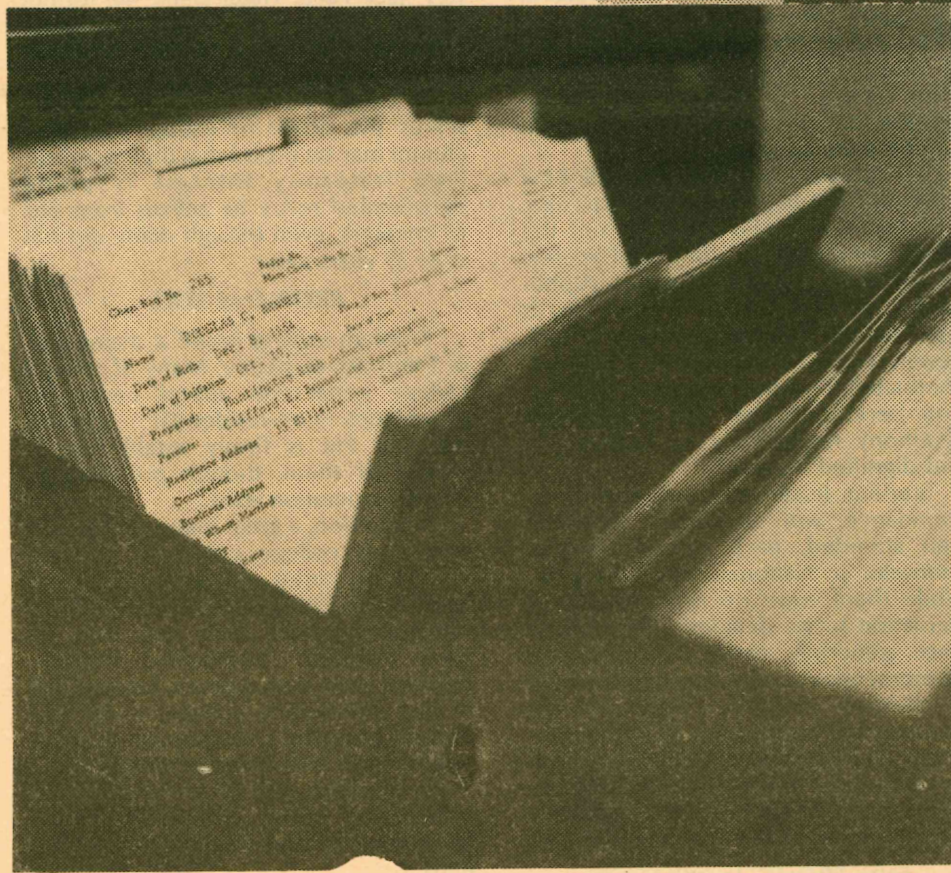
right Max Jordan, undergraduate member of the Council from the University of Nebraska, learns how to clog.



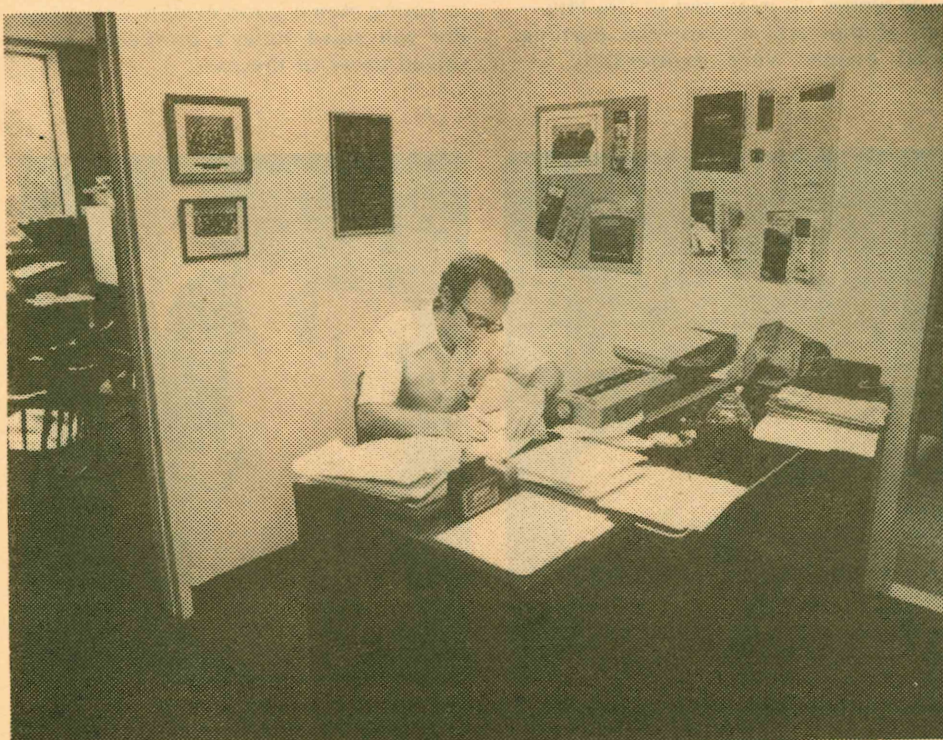
The Council Office In Pictures

Virginia College English Association (1971-73) and the Charlotte Area Educational Consortium (1970-72).

His other Chi Phi activities include serving as Regional Counselor to the chapters in North Carolina and Virginia, Alpha of the 1972 Congress, and Co-Chairman of the Chi Phi Sesquicentennial Committee. He was elected Grand Alpha at 1974 Congress, and was installed as Grand Alpha, August 2, 1975.

Brother McCall is single. His home in Charlotte provides the clues to his hobbies and other avocations. A greenhouse in the back yard is full of orchids, his home contains a splendid collection of contemporary art. The Brothers of the University of Nebraska and the University of California both won top honors in the Joe Rice Dockery M.D. competition in 1975. 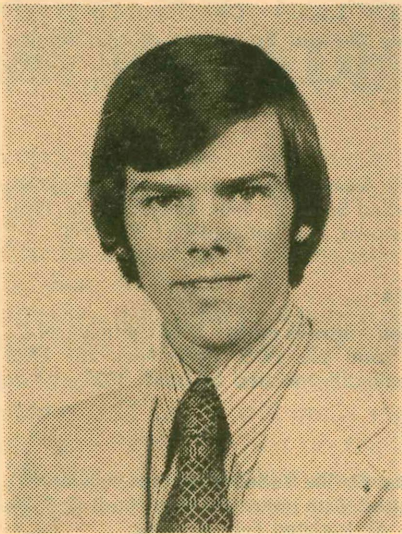
