LET'S TALK IT OVER...

(I am dispensing with the usual column to report on the Rutgers University Fraternity Evaluation.)

THE COMMITTEE on Fraternity Evaluation was appointed by Rutgers University President, Dr. Mason Gross, on February 15, 1963 because of a concern, emphasized by the general problem of discrimination, that fraternities were no longer playing the role they had in earlier days and, therefore, a redetermination of their function was necessary. Attendant to this was concern over the inadequacy of present fraternity housing and the lack of suitable accommodations to house new groups desiring to join those already established. The charge from President Gross, in essence, called for a recommendation that fraternities either be continued or discontinued.

The Committee's findings were as follows:

1. The present day fraternity chapters contribute constructively, in a unique way, to at least 40% of the student body, and the Committee therefore recommended the continuance of the fraternity system.

2. The Committee reported that a reasonable proportion of the student body in fraternity membership should be between 45% and

55%.

3. For the non-fraternity student, the Committee felt that the future residence halls should be constructed in such a fashion as to reduce to human scale the groups of undergraduates living in them. These residence halls should have an active social and educational program and should contain dining facilities, libraries, and other common rooms.

4. The Committee found that the majority of the existing fraternity quarters are inadequate and recommended the establishment of a fraternity area, on leased land at the University Heights Campus, to remedy the present housing problem. The Committee's recommendations were illustrated by the method of solution found in the Alumni Interfraternity Council's report on housing. Independence in management and finances of the fraternities appeared to be the most desirable condition to seek.

5. The Committee found that the relations between local chapters and their national organizations were generally healthy, although it recommends that a more systematic procedure of visitation by national representatives should be required by the University.

6. On the subject of membership selection, the Committee concluded that the undergraduate members should have this responsibility and that interference by alumni or




THE MAROTT HOTEL — 1964 CONGRESS HEADQUARTERS — Indianapolis, Indiana

CHI PHI 'INTERNATIONAL'



HE next five pages reflect the international flavor of Chi Phi. The story of Chi Phi at the University of Edinburgh, Scotland, is retold. A Chi Phi, and prominent Swedish business executive, tells of the value of fraternity membership. Another article gives a brief sketch of some of our foreign brothers now in school. And finally, for the benefit of our traveling Chi Phis and the brothers residing overseas, a roster of overseas members is listed. Space precludes listing our many Canadian members. The Chi Phi family includes many foreign students in addition to American brothers who are currently living abroad



A brief sketch of the foundation of the Chi Phi Chapter, at the University of Edinburgh, may not be without interest to members of the Fraternity.

Many years have passed since the writer of this article left his Louisiana home, to attend the famous Bingham school, then located at Oaks, Orange Co., North Carolina. The first battle of Manassas had been fought, and the whole country was in an uproar of excitement. The stern discipline of the Bingham school, and its retired country location, contributed much to keep down the patriotic ardor of the generous youth who filled its halls. Often the whole school would be seized with a desire "to go to the war," and it required all the tact and judgment of Col. William Bingham to talk the boys out of it.

How well he knew how to manage boys! They all believed in him and loved him. In those golden school days were formed those friendships, and were woven those influences, out of which grew the planting of a chapter of Chi Phi on foreign soil, and at an alien University.

The Old Theta University of Edinburgh

"Hoce olim meminisse jurabit"

Among the leaders of the school in those days were Henry Burnett, Peter Mitchell Wilson and Robert Bolling Wilcox to whom the writer became bound in the strongest ties of youthful friendship.

The war dragged its course along, times grew harder and harder, some of us were cut off entirely from our homes and when the vacation of 1864 arrived in July, and we bade one another goodbye, it was with a feeling that our school days were over, though our course lacked one year of being completed.

The days of peace came, the war was over, and the whilom school-boys found themselves separated at different Universities. Henry Burnett and Robert Bolling Wilcox at the University of Virginia became members of what is now the Alpha Chapter, and Peter Mitchell Wilson, at the University of North Carolina, became a member of the then Alpha Chapter of Chi Phi. The writer of this sketch was sent to the University of Edinburgh, Scotland, to complete his education, and while there was induced by his old schoolmates to found the Theta Chapter, which came into being in June 1867.


The close of the great civil conflict in America left the South in a most deplorable condition. The general ruin that overwhelmed her reached her institutions of learning, which, as a rule, became so demoralized, that they offered no attractions to those who could afford the luxury of an education. With the passions of the war still rife, Southern parents hestitated to send their children to Northern colleges, and hence immediately after the war, many Southern youths were to be found in European universities.

These influences brought a company of Americans together at that ancient and noble institution the University of Edinburgh, and when it was determined to establish a Greek letter society, splendid material was at hand out of which to build it. "Theta Chapter" sprang into vigorous life, and flourished gloriously. If the college boy in America is attached to his club, imagine the devotion of Americans on a foreign soil to a society which not only brought them together socially but which was a tie to their home, beyond the sea.

The small band passed by degrees beyond the college gates into real life; the softening influences of time healed the wounds of war; the South rebuilt her institutions of learning, the tide of Southern youth stopped flowing to foreign universities, and Theta Chapter ceased to exist.

It lives today only in the records of our Fraternity, and as an imperishable memory in the hearts of its old members.

Swedish Executive Speaks of Value of Fraternity to Foreign Students

Foreign Students who are fortunate enough to join a fraternity will find this experience at least as valuable as their formal studies, says Jonas C:son Kjellberg, Beta '53 executive Vice President, Saab Overseas, Inc., and Saab Motors, Inc.

Most foreign students with no previous knowledge of the U.S. are probably unaware of the existence of college fraternities at the time of entering an American University. Yet, I believe that those who are fortunate enough to join a fraternity will find this experience at least as valuable as their formal studies.

I believe my personal experiences, which I trust are rather typical to other foreign students, might illustrate the above statement.

In 1949 when I arrived in Cambridge, Massachusetts, I had a very limited knowledge of the English language, and an extremely sketchy understanding of the U.S. in general. So, I had to learn not only what M.I.T. would teach but also the basic facts of the "American way of life."

My brothers at the Beta Chapter could not have been more helpful in correcting my English, both oral and written; in introducing me to campus life both in regard to studies and to its social habits and activities. As I look back, I don't know how I would have managed during the first year without the tolerant understanding that the Beta brothers showed me.

As time went by, my English improved, the studies became easier to tackle, and campus life appeared familiar. Hospitable brothers would invite me to their homes for vacations, and gradually I learned more and more about this country in general — and not only of its college and fraternity life.

I am confident that a fraternity is of immense importance to any of its members, but I believe that as a foreign student I derived an absolute maximum of benefits from it. The feeling of having "a home away from home" where helpful brothers assist with whatever problems may be pressing and where a foreigner is immediately accepted as an integral part of the group is of such practical and psychological importance that I count my years at Beta Chapter as one of my richest and most rewarding experiences from which I maintain only pleasant memories and the most valued personal friendships.

With the ever increasing number of foreign students attending American Universities and Colleges it is only natural that some of them have accepted invitations to become Chi Phis.

Fraternities are distinctly American institutions, thus membership in one gives the student from abroad an opportunity to associate with American students in a way not available through any other phase of campus activity. He sees the interplay of a group designed to establish and implement its own program. He participates in elections, serves on committees, voices his opinion in meetings, visits various brothers' homes, plays intramural fraternity sports, eats American food, whether he likes it or not, and sometimes just "loafs around" in the best student tradition. The fraternity makes it a little easier to be away from home in a strange land.

Currently men from Australia, Pakistan, Iraq, El Salvador, Singapore, 'Hong Kong, Peru, Venezuela and the Republic of Panama are either members or pledges.

Kappa's pledge from El Salvador is Ricardo M. Rosenberg. Rico attended the American School in San Salvador and starting with high school, The Putney School in Putney, Vermont.

Rico is a second semester freshman at Wisconsin, majoring in International Relations and Economic Development. He is active in the International Club, International Relations Club and Mock Democratic Convention. His four years in Vermont made him a devotee of skiing in addition to the traditional summer sports of El Salvador.

countries in recent years. Without exception they have been leaders in the chapter and devoted to Chi Phi. Manmohan (Mark) Khanna is a junior at M.I.T. from New Delhi, India.

Mark has lettered twice in Soccer, is a member of Course IV-2, the honors Electrical Engineering Course, a member of the E.E. honorary society, Eta Kappa Nu, and has missed the Dean's list only once in three years. Last summer he worked for I.B.M. in Poughkeepsie. His Brothers say "He dates Wellesley with an occasional side trip to Radcliff. He plans to take graduate work at either M.I.T. or Stanford."





BROTHER WHITE, PHI '53 SETS RECORD AS BANK PREXY

At 32, Somers H. White, Phi '53, is the youngest chief executive of any American bank. White is an Amherst and Chi Phi alumnus. Brother White received his master's degree at Harvard Graduate School of Business Administration. White has served with the old Chase National and the Chase Manhattan Bank of New York, and with the Boston Federal Reserve Bank. He came to Seattle from the Guaranty Bank of Phoenix, Arizona.

Brother White's bank bears his stamp. The Seattle area's 1,000,000 population look upon North West Bank as "different." The bank is located in the corner of a 10 story downtown parking garage, where it maintains free parking privileges for its customers.

Although there is a convenient offstreet motor banking window, most customers prefer to turn up the ramp, park and transact their banking business inside.

The customer's first impressions are of red wall-to-wall carpeting, rich teak-wood paneling and the fact that everyone usually wears a smile.

There are other little things that make North West Bank different. No rails separate officers' desks from the carpeted lobby. Tellers stand within a rectangular enclosure near the center of the banking room. Some of the teller stations have stool-chairs for sit-down banking. And, in the opinion of most of its male customers, tellers and other female employees are among the prettiest girls in the area.

Brother White has other innovations among Seattle banks. North West offers services with a "plus." Examples are: a Check-a-Month savings accounts which enables customers to receive monthly income checks figured at daily interest on deposits, and a free personal checking account service. On the latter, there is no service charge provided a \$500 balance is maintained.

The new bank is completely automated. Not only are North West's checking accounts handled by machine, but so are its savings accounts, savings interest computations, installment loan books and payments, and even its general ledger and payroll accounts. Recently the bank made available certain specialized bookkeeping services to its business customers, using this automated equipment.

Brother White considers the average age (36) of his officers one of his bank's primary assets. However, we feel the main asset of North West Bank is a well-known Chi Phi Amherst graduate.

Going on 96 and still walks at least two miles a day

Brother Alten S. Miller, Mu 1888, is certainly one of Chi Phi's oldest and most illustrious members. He was born in Richmond, Virginia, October 6, 1868, and was initiated by Mu, April 2, 1886. This month marks his 78th year as a Chi Phi. Brother Miller was not a charter member of Mu, however, he is number fifteen on the Chapter register and Mu's oldest living member. It is possible he is Chi Phi's oldest living member.

His career as a professional Engineer was distinguished, as indicated by the list of societies, clubs and honors listed in Who's Who in America. He holds the degree of Doctor of Engineering. He is the oldest member of the Engineers Club of New York, having joined in 1894. He was elected President of the Union Electric Company of St. Louis in 1909, but left the position in 1911 to return to New York to become a consulting engineer.

During World War I he was a munitions manufacturer specializing in shrapnel with fuses. In 1918 he was appointed Lieutenant Colonel, Army Ordnance and was placed in command of the Department of Design of Army Ordnance. He was detached at the end of the hostilities.

Brother Miller says, "The rest of my business career was spent in consulting

EDITORIAL

Let's start with this quote from Ray E. Blackwell: "Separated from its institutional affiliation the Chapter ceases to function as an active fraternity chapter."

The University welcomes a chapter with high academic, social, activity, and financial rating. This requires a well organized chapter with good officers who accept their responsibility to the University as well as to the Brothers and Pledges. It is up to them to promote the proper liaison between faculty and chapter.

Scholarship is of prime importance. This means that the Brothers and Pledges must have good grades. A controlled, compulsory quiet period for study is essential. It's a help, too, to have those proficient in special subjects assist and tutor those less proficient. The most important thing, though, is the selection of pledges.

I have noted that chapters who emphasize the social functions above all else and neglect study or quiet hours, the more important extracurricular activities and a sound financial program are among the weaker chapters of our fraternity.

One of the most important assets to a chapter is the close relationship of the advisor to the Brothers and Pledges. This is vital for a successful chapter.

A chapter that has responsible officers, who command the respect and cooperation of Brothers and Pledges, well balanced social and activity programs, a sound financial organization and close contact with the advisor will usually have a good academic standing. To maintain this ideal the chapter must be ever mindful of its mental, moral and spiritual goals when selecting officers as well as during rushing. The result is well worth the effort. This is the kind of a chapter that reflects credit on our National and is approved by both the University and the community.

work. Mainly the work was the determination of the cost and the present value of public utilities and testimony before courts and commissions regarding these items and the efficiency of the operations.

Our socialist supreme court ruined the business by issuing an order that value had nothing to do with utility charges for service. The basis for utility rates must be original cost and, when the dollar goes to nothing the loss is that of the utilities. No appraisals are now useful."

Brother Miller lives in Princeton, New Jersey, still drives his automobile and walks at least two miles a day. On April 2nd the Council sent him the following congratulatory message: "The Council and all the members of the Chi Phi Fraternity congratulate you on the 78th anniversary of your initiation into Chi Phi. Records indicate that you have been a Brother in Chi Phi longer than any other member. Best wishes for continuing good health.

Request for Nominations of Candidates for Office of Grand Alpha

The Grand Alpha Nominating Committee requests that the names of candidates for the office of Grand Alpha, and their qualifications, be submitted to the committee no later than July 15, 1964.

Section 1, Article XI of the Constitution outlines the duties of the Committee as follows:

"The Grand Alpha shall be elected by the Annual Congress for the year 1922 and by the Congress held every second year thereafter, and he shall be at least twenty-five years a member of the Fraternity at the time of his election. The Grand Alpha-elect shall immediately become a member of the Council and shall attend all Council meetings as a member which are held during the rest of the fiscal year ending July 31st. The Grand Alpha shall hold office until his successor has been elected and qualified.

The Council shall select a committee, at least one year prior to the year in which election takes place, to nominate a candidate for the office of Grand Alpha. The committee shall be composed of five former Grand Officers, two of whom shall be past Grand Alphas. The committee shall select their own chairman. It shall be the responsibility of the committee to circulate a notice among all of the chapters and accredited alumni associations and clubs of the forthcoming election and request the submission of names of candidates and their qualifications for the office of Grand Alpha. The Committee's report will be made prior to the election of the Grand Alpha at Congress, and shall be considered dissolved immediately after the election.'



ALCOHOL



WE always have had alcohol with us and we are likely to have it with us for some time yet to come. There are some people who for religious, cultural or social reasons are going to drink, and there are others who for the same reasons are not going to drink. Our difficulties in dealing with the drinking of alcohol do not stem from the people who do NOT drink! Our trials and tribulations stem from all those people who for reasons both good and bad drink alcohol and intend to continue to drink. Our quandary, however, with all those people who drink and who intend to continue to drink can be solved only if we all recognize that one in fifteen is a potential alcoholic. Knowledge about moderate drinking is important but the issue of moderation has little to do with alcohol.

If we could teach the basic information about alcoholism to everybody, we would, surely have answered as completely as is possible questions raised by alcohol on the campus. This basic information must be understood and accepted by ALL students, teachers and

EDITOR'S NOTE: I visit many campuses and talk to innumerable college students every year. Most of those I meet are male and members of fraternities. Many of our members do drink beverages containing alcohol. Most of these that do drink did not have their first drink at a fraternity party or a fraternity sponsored party. They drank before college. Most students I meet do not drink during the week. If they do drink it's on weekends.

is in any way very effective, until we are able to affect a change in our entire intellectual and spiritual climate so far as alcohol is concerned. The necessity for the creation of this intellectual and spiritual climate might seem to be an impossible task and a sign of hopeless pessimism but, in my opinion, if we might and would provide a significant and valid program for teaching the basic information we now possess about alcohol and alcoholism in our colleges and universities, then and only then could we have, in a reasonably short time, the change in climate which would allow us to influence the conduct of students in relation to alcohol.

Seven Basic Facts in Alcohol Education

- Approximately one (1) person in fifteen (15) is a potential alcoholic. Fourteen are not. This ratio holds good in ALL groups.
- No person can know in advance of his drinking if he is or is not a potential alcoholic. Therefore EVERY person, whether he drinks or not, must know the facts about alcoholism.
- An alcoholic is a person who RE-PEATEDLY gets into trouble after drinking but who continues to drink and, as a result, gets into trouble again.

- An alcoholic can NEVER drink alcohol in any amount however small without having serious consequences.
- There is no one generally accepted cause, nor is there any known cure, for alcoholism.
- 6. The symptoms of alcoholism can be observed in people of any educational level, socio-economic group, age, sex, race or creed very soon after the person who drinks is free to drink as much or as often as he desires.
- Alcohol education is education in a "way of life," plus basic information. Either one without the other is actually harmful whenever alcohol is involved.

A Program in Brief

- Every student who gets into any kind of trouble, however minor, should talk with a trained alcohol counselor who can present the basic information without making moral judgments.
- Every student who gets into serious trouble must be placed upon disciplinary probation with the understanding, shared by the student, his parents and others interested, that suspension from the university is a certain consequence of a second serious incident in which alcohol is involved.
- 3. An expert speaker on alcohol, preferably a member of Alcoholics Anonymous, should be available to all student groups and the group should be urged to hear such a speaker at least once each year.

Conclusion

This approach to alcohol education leaves no room for intolerance; it leaves no room for bigotry; it leaves no room for arrogance; it leaves no room for hypocrisy. Above all, it leaves no room for those who cannot learn something new. It requires hard work, intelligence, and faith in ourselves, in God, and faith in others. Above all, we must have the patience of Job and the courage of a fool, without becoming one.

LAMBDA BUILDS A NEW MUG RACK

Ever since the founding of the Lambda Chapter of Chi Phi, it has been a tradition to present pewter mugs to the new initiates. These mugs are engraved with the brother's full name, nickname, and class. When a brother dies the glass bottom of his mug is shattered as a token of respect.

Associated with the tradition of the mugs is the practice of displaying them on a shelf in the house. The mugs are arranged according to class years, and thus serve as a decorative history of the Lambda brothers.

Through the years various problems had arisen with regard to the mugs on display. Many were stolen during open houses, while others were broken, scratched, or badly dented. It became too costly to keep the mugs on open display, and for the past few years the remains of the old collection were locked in the chapter room.

In the summer of 1963, actives and alumni of Lambda set to work to build a rack which would secure the mugs, yet keep them on open display.

The mug rack, designed and built by Robert Haaf L'50, measures seven feet by ten feet, with thirty individual shelves, has a total capacity of threehundred mugs. The shelves, made of fine, dark walnut, are each fitted with a sliding bar which closes to lock the handles of the mugs into elbow hooks built into the wall of the rack. This device makes it possible to display all the mugs while keeping them safely locked. Also the mugs can be quickly unlocked and removed when necessary. Special credit is due to William Long ('64) and Barden Wilmar ('65) who assembled the rack.

This rack, filled with mugs, is not only a useful addition to the Lambda house, but is also a striking decoration of the dining room, where it is situated.

Now that the rack is finished and the mugs can be displayed without fear of theft or damage, Lambda urges all its alumni to return or reorder their mugs.

A STATEMENT OF POLICY BY NORMAN TOPPING, PRESIDENT OF U.S.C.

"The University of Southern California, from its inception, has maintained a policy pertaining to student affairs which is free from discrimination based on race, religion, or national origin. The following-part of a resolution adopted by the Board of Trustees-supports this policy, and appropriate affirmation of it will be required:

All fraternities, sororities and other non-institutional living groups and student organizations shall be free to select their own members free from any express or implied restraint imposing discrimination against such selection based upon race, religion or national origin . . . Said policy . . . shall become effective with the opening of the school year in September, 1964.

It is my conviction that the fraternities and sororities on our campus are a source of great strength, providing leadership complementing the academic objectives of our university. I am confident that they will help provide leadership in this matter, as well.

It is the intent of the policy to insure freedom of choice in the selection of members by each fraternity and sorority. The University recognizes the valuable contribution made by alumni and alumni advisory groups to the affairs of the fraternity and sorority programs. This policy contemplates a continuance of strong alumni-chapter reincluding guidance with lationships, respect to selection procedures and the selection of members. It should be clearly understood that the University will not require any fraternity or sorority to invite into membership anyone not acceptable to its members.

Most assuredly, the hope of this university's administration and trustees is that fraternities and sororities will continue to contribute, as they have so richly in the past, to the intellectual and social environment of their members, of the University, and of all its students."

others outside the student body was unhealthy. The Committee found that no national fraternity represented at Rutgers has in its constitution any membership restrictions based on race, creed or religion. One fraternity was unable to effect such a change and the chapter was disbanded in 1959. Now that the technical methods of discriminating have been removed, the Committee found that the slower process of enlightened selection is in evidence.

7. In discussing initiation practices, the Committee was unanimous in its condemnation of the distasteful aspects of so-called "Greek Week." The Committee strongly suggests the immediate abolition

of "Greek Week" in its present form. The Committee members were assured that the undergraduate I.F.C. was in the process of investigating a more acceptable initiation week program which will be more in line with the ideal of the fraternities and the University. The Committee feels strongly that the University should take the responsibility for preparing and insuring such a program.

In summary, the Committee recommended to the University and to the fraternities that they establish their common goals in a more consistent fashion to eliminate the slightest doubt about the community of interest shared by the fraternity system and the University.
